## AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF

PESOLVED, that the Declaration of Condominium and the By-Laws of the corporation shall be amended as follows:

- Eliminating the right of unit owners to rent their units except under the following conditions:
- (a) Leases to corporations or business entities shall hereafter not be permitted.
- (b) That no unit shall be leased more than once during any year. For the purpose of this resolution, a year shall be defined as the twelve (12) consecutive months commencing with the date of each lease.
- (c) That the term of the lease shall not be less than four (4) months during any year.
- (d) That an application, on forms to be supplied by the Association, be made to the Association for approval of the lease, which application shall be made accompanied by a \$50.00 fee.
- Any provision in the Declaration of Condominium as amended and By-Laws authorizing the sale of a unit to a corporation or business entity is hereby surogated and hereafter a corporation and/or business entity shall not have the right to become the owner of a unit.
- We further certify that the above amendments do not affect the interest of the lessor of the long-term recreational lease.
