

DOVAHKIIRA'S SHOP — TERMS OF SERVICE

Welcome to Dovahkiira's Shop (the "Site"). The Site is owned and operated by Dovahkiira ("I", "me", "we", or "us"). By using the Site, you agree to be bound by these Terms of Service (the "Agreement"). If you do not agree to these terms, please do not use the Site.

1. General Use

The Site is an online marketplace for stickers and digital art downloads. I offer a variety of stickers and art downloads (collectively, the "Products") for purchase through the Site. By placing an order through the Site, you agree to pay the full amount of the purchase price for the Products, plus any applicable shipping and handling fees and taxes.

2. Intellectual Property

All digital art files on the Site, including but not limited to images, logos, and PDF files, are the property of Dovahkiira and are protected by applicable intellectual property laws. You may not copy, distribute, modify, or create derivative works of any digital art files on the Site without my prior written consent.

3. License

When you purchase a digital art file from the Site, you are purchasing a license to use that file for personal, non-commercial purposes only. This license does not transfer ownership of the file or any intellectual property rights associated with the file. You may not sell, distribute, or otherwise transfer the file to any third party without my prior written consent.

4. Orders and Payment

Orders may be placed through the Site using a valid payment method accepted by us. I reserve the right to reject or cancel any orders, in my sole discretion, for any reason, including but not limited to: if the Products are no longer available, if I suspect fraudulent or abusive activity, or if there is an error in the pricing or description of the Products on the Site.

5. Shipping and Delivery

I will make every effort to ship the Products to you as quickly as possible. Please note, however, that delivery times may vary depending on your location. I am not responsible for any delays or other issues that may arise in connection with shipping or delivery.

Please allow me 1-2 business days to ship your sticker order and provide a tracking number. My offered method of delivery is USPS First-Class Certified Delivery, which is a cost-effective and trackable service. Please allow between 2-14 business days for delivery.

Upon successful payment, the purchased digital art files will be available to download from the site as a high-quality PDF file.

6. Returns and Refunds

I want you to be completely satisfied with your sticker purchase. If for any reason you are not satisfied, please contact me within 14 days of receiving your sticker order to request a return or exchange. All returns and exchanges are subject to my Return Policy, which is available on the Site.

Due to the nature of digital downloads, all digital download sales are final and I do not offer refunds or exchanges unless there is a technical issue with the downloaded file that prevents it from being used as intended. In such cases, please contact me within 14 days of your purchase with proof of technical issues, and I will make every effort to resolve the issue.
