## Semi-Annual Meeting March 11, 2022

At the semi-annual meeting, Alan Offen was unanimously approved to take the remaining portion of George Fiegel's term as vice-president. George is moving Michigan. All our best to George, who has been a stalwart crusader for the TCCC. And of course: congratulations, Alan!!

At the meeting, TCCC members voted to approve the following changes to the bylaws:

Article III Paragraph A (MEETINGS OF THE MEMBERS) ratified on 3/10/2018

is hereby amended to delete said paragraph and replace the same as follows:

> "There shall be two semi-annual meetings of the membership which shall be held during the Second and Fourth quarters. In this regard, the fiscal and business year of the Association shall commence on October 1 and terminate on September 30. The quarters shall be as follows: FIRST: October – December, SECOND: January – March, THIRD: April – June, FOURTH: July – September. All appropriate business shall be conducted during said meetings including reports from all officers and standing committees. The annual election of members of the Board of Directors shall take place during the FOURTH quarter. The second annual meeting shall take place during the SECOND Quarter. The exact time and place for the two annual meetings shall be determined by the Board of Directors. The term of office of each Director shall commence on October 1 and run for the period of time set forth in these Bylaws."

Article IV (CLUB MANAGEMENT) ratified on 3/10/2018 is hereby modified as follows:

 "In the second line deleting the words 'third quarter' and replacing them with the words "fourth fiscal and business quarter' to come into compliance with the Amendment to Article III Paragraph A."

- Article IV (CLUB MANAGEMENT) Paragraph C Subparagraphs 3 a) and b) (VACANCIES) ratified on 3/10/2018 shall be amended to delete said Subparagraphs and replace the same as follows:
- "a) If the office of President shall become vacant for any reason, the Vice President shall immediately assume the office of President and an emergency meeting of the entire Membership shall be called and held within 60 days of the vacancy to elect a new Vice President who shall complete the remaining term of the Vice President as provided for by these By-Laws. In the event the remaining term of the new President (former Vice President) shall be five (5) months or less, the new President (former Vice President) shall then serve his/her regular one-year term as President at the beginning of the next business year (October 1). If the term is more than five (5) months, the newly elected Vice President shall become President as provided in the Bylaws."
- "b) If the office of Vice President shall become vacant for any reason, including said Vice

President becoming President as a result of Subparagraph a) above, an emergency meeting as provided for in Subparagraph a) above shall be held to elect a new Vice President who shall complete the remaining term of the Vice President as provided for by these Bylaws and pursuant to Paragraph a) above."

Article VI (GENERAL PROVISIONS) ratified on 3/10/2018 is hereby amended to add the following paragraphs which shall be labeled Paragraphs D & E:

- "D. Committees Committee members need not be Board members; however, there shall be at least one Board member on each committee. The Chairperson of the Committee shall report to the Board at the monthly Board meetings as to the activities of said Committee."
- "E. TOURNAMENT MANAGER –
   The Tournament Manager need
   not be a Board member but shall
   be entitled to participate in all
   general and Board meetings as if
   he/she were a Board member but
   shall not have the right to vote as
   a Board member."

The Tega Cay Croquet Club has a different website -- visually different, that is. We can't call it new because it is in the same place as it has been and most

of the content of the previous website has been relocated to this one. What is different is its appearance, its layout, and the addition of some new items. The *really new* part is behind the scenes and not seen by the user, the part that makes it easier to maintain and update.

Our website provider, GoDaddy.com, has improved its web hosting services and will be encouraging customers to move to its newest web platform. Changing to the new platform is a question of when, not if, and doing it now is a convenient time for us. Making the change will give us a better web presence, for the same cost, and a site that easier for us to update, making switching to it a no-brainer if there ever was one. We completed putting our website content on the new platform and made the change over on February 8th. The change does not affect site users because the new version comes up when you go to the same old web address. We encourage everyone to go look at it. When you go to the website, here are some of the things to look for:

 The site can be viewed not only on a desktop or laptop computer, but it also reformats itself to look good on a smart phone. (If you are not familiar with using a website on your phone, look for the icon in the upper left corner [≡]. Selecting this icon will open the navigation menu to access the rest of the site. The menu is the same as the one at the top of the page when viewed on a computer screen.)

- The most-often mentioned reasons for members to go to the website --Court Reservations, Upcoming Event Schedules, and Recent Event photos -- are now conveniently located on the homepage as well as on the top of the page menus.
- Links to rule books for golf croquet, 6-wicket, and other games have been collected and organized.
   They can be checked on a phone at the court.
- Content has been added to make it a better reference site for prospective new members, with club information on the "Homepage" and on the "About Us" page.
- Content of specific interest to club members has been collected and expanded. It is accessed from the "Members Only" tab on the menu. Contact information on the members list and the sub list is password protected.
- Content about the US Croquet Association has been added and organized.

### **New Storage Building**

A week after the Annual meeting, via email, the majority of the members approved the TCCC Board to spend \$5,358.67 for the construction of a Croquet Storage Building at the Croquet Court as proposed by the City of Tega Cay to cover 50% of the bid cost for the building as defined in the City's Request for Bid document dated 1/27/2022. The City will schedule a pre-construction meeting with the contractor. No construction start date has been determined. The date should be determined during the pre-construction meeting.
