## Director's comments

Three years of anxiety, uncertainty, fear, infections, illness, and death are now all behind us. The reporting year from March 2022 to February 2023 signaled the beginning of the end of the deadly Covid19 pandemic.

We witnessed and welcomed a massive decline in the global infection rates. By the end of the 3<sup>rd</sup> quarter, most restrictions on movement, gatherings, mask wearing, and other prevention strategies have been lifted. And the world opened!

Molo Songololo is very grateful for the wonderful support received from our supporters, the children, and young people we work with. Big thank you to all the volunteers and those who mobilise their family, friends, and colleagues to give and contribute to our many calls for cash and kind donations we made.

We are also grateful for the funding received from the Department of Social Development, Western Cape government, The National Lotteries Commission, the Luzar Foundation, and the many individual givers who contributed.

With limited funding, teamwork, and determination of staff, we managed to continue to provide essential services to child victims, those at risk, their parents and families, and local community members in our target areas of Atlantis, Beaufort West and Delft. It is a pleasure to report the following achievements:

- 258 child victims and those at risk of sexual abuse, exploitation and trafficking in children received assessment, counselling, empowerment, and support services.
- 256 parents of child victims and those at risk received assessment, counselling, empowerment, and support services.
- 107 child victims and those at risk took part in various received therapeutic sessions.
- 13 parents of child victims and those at risk took part in various received therapeutic sessions.
- 4489 children took part in public education sessions to prevent child sexual exploitation and trafficking in children.
- 591 parents took part in public education session.
- 5500 children took part in rights and responsibilities and life-skills sessions.
- 10 000 children took part in the summer school holiday programme in Atlantis and Delft.

The 2022-2023 reporting year ended on a very positive note. Funding grant from the National Lotteries Commission was received, a full motivated board was in place, and staff felt relieved that the Covid19 pandemic restriction was lifted. And a very successful 5-week school holiday programme in Atlantis and Delft.

For the new year, the Board and management committed to drive a strategic review and planning process of reflection and planning aimed to strengthening the organisations operations and funding.

## Board and staff.

### **Governance: The Board of Directors**

Four new members were elected to the Board of Directors at the Annual General Meeting held on 3 September 2023. Two members of the previous years' board was re-elected. The Board elect, which meets every quarter, now include the following persons:

### **Management: Director, staff, and volunteers**

The Molo Songololo staff consist of full-time and part-time staff, supported by volunteers when needed. During this reporting year all staff salaries were reduced due to lack of funds. Salaries was adjusted in the 4<sup>th</sup> quarter with the availability of new funding.

Our management and staff component for this reporting year consisted of the following: -

- Volunteers – 18 were contracted and paid stipends.

Despite financial challenges, reduction in staff salaries and three resignations; Molo Songololo ended the year on a positive note. By February 2022 the three vacancies were filled. Job security and sustainability of the organisatio are key factors that needs attention.



# Child protection and victim empowerment

The main funder of this programme is the Department of Social Development, Western Cape, the National Lotteries Commission, and individuals that make cash or kind donations. The purpose of this programme is to prevent and combat sexual violence committed against children, i.e.

- Child sexual abuse
- **Child sexual exploitation – the main focus**
- Child trafficking

During the 1<sup>st</sup> half of the reporting year, due to Covid19 pandemic restrictions, the bulk of the work focus on the provision of prevention and early intervention social support services to individual clients (child victims of sexual violence, and their families) through:

- Receiving and making referrals.
- Assessments and follow-up interviews and info gathering.
- Basic counselling, therapeutic and empowerment sessions.
- Regular home visits and monitoring of clients and family.
- General support – reporting, statement giving, court, school, and family.

Despite the many challenges presented by the Covid19 pandemic restrictions and its impact, Molo Songololo staff in this programme was able to provide essential support services in Atlantis, Beaufort West, and Delft to: -

- **258** child victims (survivors) and those at risk of child sexual abuse and exploitation
- **256** parents of child victims and those at risk of sexual abuse and exploitation

With the lifting of Covid19 pandemic restriction, we were able to re-introduce our group work, educational sessions and workshops, and public education activities with clients, community members and service providers. For this reporting year we achieved the following:

# Child sexual exploitation Complexities

Although most people will agree that for adults to have sex with children are illegal and a crime, many turn a blind eye to the sexual abuse and sexual exploitation of children by adults.

In this reporting year we have observed and worked with cases that indicate,

- Children and adults have daily access to sexual content and sexual abuse images via their cell phones.
- Men target teenagers for sex have easy access to them via cell phones.
- Men give girls cell phones to stay in contact and groom them.
- Older teen boys and young men offer girls stuff in exchange for sex.
- Men give girls and boys things in exchange for sex or to organise others for sex.
- Men in position of power, like teachers, police, and others, give girls stuff and have sex with them.
- Some parents receive stuff and condone their child's "sexual relationship" with an adult man.
- Girls, boys, and men take and send sexual images of themselves or others via their cell phones.
- Children and adults post sexual images on social media as revenge when couples break-up.
- Teen boys and men blackmail girls with exposure and force them to have sex with them.

Awareness of the nature of child sexual exploitation and the criminal offences that are committed are lacking. Thus, identifying and reporting cases are most difficult.

Molo Songololo uses every opportunity to prevent and combat these crimes against children through public education.

### What is child sexual exploitation (CSE)?

It is a **type of sexual abuse**. It is when a child (person under 18-years) is taken advantage of, manipulated, groomed and used for sexual purposes in exchange for a reward or benefit to child or anyone.

The reward or benefit can be for favour, food, gifts, airtime, cell phones, alcohol, drugs; or money, shelter, fear, affection, status, etc. in exchange for performing sexual activities or the exploitation of child sexual abuse images and content.

**What are sexual offences?**  
Sexual offences are any exposure to, grooming for, forced, unwanted, unlawful sexual content, conduct, acts or purposes achieved with consent, or without consent in relation to a child or disabled person

- Sexual offences include:**
- Exposure to sexual content or behaviour
  - Grooming someone for sexual purposes
  - Sexual assault – any non-penetrative sexual assault
  - Compelled sexual assault – forcing someone to commit a sexual assault
  - Rape – any forced and unlawful penetrative sexual acts
  - Compelled Rape – forcing someone to commit rape
  - Statutory rape – rape of child of a certain age by adult or older child
  - Incest – sexual acts with a family relation with or without consent
  - Child pornography – any content or images that reflect a child in a sexual way or the sexual abuse, assault, or rape of a child.
  - Sexual exploitation – any reward or benefit derived from committing a sexual offence
  - Trafficking for sexual exploitation – to procure, move, hold captive and sexually exploit someone.

**Who is a child at risk?**  
It is a child who is experiencing or is at risk of experiencing neglect, abuse, violence, exploitation or any other harm or conditions that threaten his/her safety and wellbeing.

- A child at risk is also a child who:**
- is in need of care, support, shelter and protection.
  - is abandoned by parents or who have no parental support and fend for themselves or siblings
  - use and abuse alcohol and drugs
  - drop out of school and forced to work
  - Involved with gangsters or hang out with adults
  - Is sexual active and have sexual relations with adults
  - Ran away from home and live on the street
  - Poverty and hunger

# DIGNITY FOR GIRLS, every day, everywhere!

Most of the children (beneficiaries) Molo Songololo work with are from poor families and lack food security and regular access to basic personal products that can maintain their self-respect and DIGNITY.

Period Dignity is a major challenge for MOST of the girls we work with. Every year Molo Songololo conduct two donation drives for sanitary pads and toiletries, or cash donations for a DIGNITY GIRFT BAG.

A Dignity Gift Bag consist of a 3-month supply of personal products that girls can use to maintain Period Dignity,

- Sanitary pads
- Face cloth, soap, body lotion
- Toothpaste and toothbrush
- underarm deodorant, body spry
- shampoo, conditioner,
- Vaseline and other small feminine products
- Treats, etc.

The Nelson Mandela Day Challenge donation drive is conducted during June and July. The gift bags are distributed in August to girls in Atlantis, Beaufort West, and Delft,


- 300 Dignity Gift Bags
- 300 Mandela Day Lunch Packs & 300 Meals

The Xmas Giving Challenge donation drive takes place during November and December and the gift bags are distributed during month of December in Atlantis, Beaufort West, and Delft to girls in need.

- 250 Dignity Gift Bags

All the satellite offices stock sanitary pads and basic toiletries so that children can have access to products when they need them.

**#Dignity4Girls** is also an awareness raising campaign to promote respect for girls and their natural sexual reproductive health, rights and reduce period stigma and discrimination.

# Mandela Day Meals

Many children and youth in Molo Songololo's target areas of Atlantis, Beaufort West, and Delft lacks food security. The negative impact of Covid19 further stressed poor households and children have less nutritious food to eat. In some cases, they only have one meal a day.

We appeal to our supporters and members of the public to,

# IT'S YOUR MOVE - Child and youth empowerment

The name of the Molo Songololo Child & Youth Empowerment Programme is called ITS YOUR MOVE (IYM). The programme includes several focal activities targeting child and youth from

- 12 to 14 years Primary School learners
- 15 to 17 years High School learners.

Like the CP&VEP this programme is mainly located in the target communities of Atlantis, Beaufort West and Delft and include the following activities.

- **IYM Children's Forum** – consult with children on issues that affect them.
- **IYM Empowerment** – empower children on rights & Responsibilities, Life-skills & Leadership skills.
- **IYM Young Women's Forum** – gender specific peer dialogue and empowerment.
- **IYM Young Men's Forum** - gender specific peer dialogue and empowerment.
- **IYM Child Participation & Advocacy** – children take part, express their views on decisions that affect them, and social action campaigns.

About 5000 children took part in the activities of this programme. We highlight some of the activities on the next pages.

THE MOLO SHOW – is a weekly radio programme produced by Molo Songololo's Chloe Johnson and broadcasted weekly on Radio Atlantis. The show target and involve children and youth from 12 to 17 years.

It focus on current affairs and create dialogue and public awareness on

- Challenges and difficulties of children
- Children's safety and protection issues
- Children's activities and achievements
- Peer learning and support
- Children interests, needs and rights

# IYM - Children's forums



The UNESCR Commissioners want to know from children all over the world what their views and experiences are of how their government are respecting and implementing economic, social and cultural rights of people and children. The three themes focussed on;

- Equality and Non-discrimination
- Climate and environmental harm
- Sustainable Development and Natural Resources.

The UNESCR commissioners will use the views and opinions of the children in their global report to governments and include children’s experiences, views and opinions on the three main issues.

- Climate and environment (good living conditions on our planet and the natural world around us).



# IYM- Child participation and advocacy

Molo Songololo Children's Forum from Atlantis, Witsand and Delft met and discuss the Children's Amendment Bill and made recommendations which they presented to the Provincial Parliament.



The Bill is to make changes to the Children's Act. They said "children have a right to take part in decisions affecting them. We are excited to be here. But we are also very nervous ". It was their first-time taking part in a public participation process and visiting the Provincial Parliament.



Some of our older members, those who are now 18 -years old and over, did take part in previous public participation processes on the Children's Act and the Sexual Offences Act. Unfortunately most children are not aware that they can take part.

The Children's Act promotes the rights, care, and protection of children. It is a guideline of how children must be treated when they need help, assistance, and support.



In our local communities of Atlantis, Witsands, Delft, Mfuleni and Blikkiesdorp, children experience many problems. Many do not enjoy the rights set out in the Constitution or in the Children's Act.

Many children are suffering, don't get enough food to eat. They are abused and hurt by adults and their parents. They are exposed to violence and crime, and many are killed. We feel unsafe and fear for our lives every day.



We agree with the changes and make further suggestions in our document to improve protection for children in the Children's Act: said Mbali Botha, 13 years from Delft and Shirnay May, 17- years, from Atlantis.

# IYM - Young Women's Forum / Young Men's Forum

The It's Your Move - Child and Youth Empowerment Programme includes two gender specific platforms aimed to:-

- Inform and empower children on gender related issues.
- Facilitate peer dialogue on gender specific issues and challenges.
- Identify gender related experiences, concerns, challenge, and violence.
- Develop strategies and take action to prevent and combat gender related abuse, violence and exploitation.




## IYM – Young Women's Forum (YWF)

This platform is for girl children and female members of IYM from 12 to 17 years in Atlantis, Delft and Beaufort West. The YWFs allow teenage girls to engage their views, experiences, and opinions openly and freely with the female peers.

## IYM – Young Men's Forum (YMF)

This platform is for boy children from 12 to 17 years in Atlantis, Beaufort West and Delft, and are held separately from the Young Women's Forums. Like the girls, the boys to engage their male peers on gender related issues that affect them openly and freely.




Unfortunately, due to the Covid19 pandemic and financial challenges we were not able to implement all the forums planned for. We managed to have five forums, 3 for girls and 2 for boys: involving 56 girls and 23 boys.



During the annual 16 Days of Action campaign the YWF members conducts a public awareness campaign to prevent and combat PUBLIC SEXUAL HARRASSMENT OF CHILDREN, especially girl children.

- Both forums also promote and combat,
- gender equality and non-discrimination.
  - gender-based violence.
  - child sexual exploitation.



# IYM – Empowerment: School holiday programme

2500 children took part in the December 2022 to January 2023 School Holiday programme.

Molo Songololo was contracted by the Western Cape Department of Arts, Culture and Sport to organise the programme for children in Atlantis and Delft.

Main target age group were children and youth from 12 to 17 -years of age. We also had some younger and older children taking part in the programmes.

The programme took place over 25 days , Mondays to Fridays, from 12 Dec 2022 to 13 Jan 2023. Due to the holidays, two workshops were held on Saturdays , 7<sup>th</sup> and 14<sup>th</sup> January.

The time schedule was as follow:

- Daily start time: 10h00 – children was encouraged to arrive early.
- Lunch break: 12h30 – time to have refreshment, rest, and chat to new friends.
- Daily end time: 15h30 – children encourage to help clean up venue at end of day.

Holiday programme thematic topics was developed and engage participants in a fun and interactive way.

- Mondays – Child Rights and Responsibilities
- Tuesdays – Community Awareness and Social Responsibilities
- Wednesdays – Gender Equality
- Thursdays - Child Safety & Protection
- • Fridays – Preventing sexual violence.

Volunteers were trained and supervised by Molo Songololo. 12 volunteers received a stipend and was paid weekly.

There is a great need for school holiday programmes for children in the target areas of Atlantis, Beaufort West, and Delft.



# IYM – Western Cape Commissioner for Children

The Western Cape Commissioner for Children, Ms Christina Nomdo, visited the Molo Songololo 's It's Your Move members in Beaufort West.

For many years, Molo Songololo and It's Your Move members campaigned for the establishment of an INDEPENDENT champion and protector of children and their rights.

Christina Nomdo is the first Commissioner appointed on 1 June 2020. She will be the commission for 5 years. She now has completed 3 years on 30 May 2023.

It 's Your Move members expressed the following to the commissioner;

- Children in Beaufort West and elsewhere do not know the commissioner, Children is not aware of that the commissioner is supposed to do and who the commissioner report to.
- What to know what the commissioner has done for children, and how the commissioner protected children.

The It's Your Move Members also highlighted the many hardships children experience, i.e.

- Poverty and hunger Abuse and neglect by parents
- Substance abuse by parents and children
- Domestic violence and social crime
- Sexual abuse and sexual exploitation
- Boys and men making girls pregnant.
- Children dropping out of school.
- Parents not having jobs and earning low wages.
- Lack of opportunities and services for children

The It's Your Move members in Beaufort West found the engagement useful and was glad to have met the commissioner. They are however very sceptical if the commissioner will be able to be the protector and defender of children and their rights.



# Building capacity of service providers

The year kicked off with a very successful stakeholder Forum in Beaufort West aimed to reduce barriers, strengthen cooperation, improve reporting, and management of GBV, especially child sexual exploitation.

34 services providers from various sectors attended the stakeholder forum which was conducted by Patric Solomons and Charlotte Pankhurst. Participant included representatives from the Police, Social Development,

Education, Health, NPA-Courts, Correctional Services, NGOs and Community groups. A similar capacity building workshop was held in Atlantis for stakeholders from the areas, as well as Mamre, Pella and Witsands. 27 representatives attended the workshop. The outcomes for these capacity building workshops included.

- Updated database of services providers shared with stakeholders.
- Improved cooperation and referrals of child abuse cases.
- Reduction of barriers that hampered the reporting of cases to the police.
- Awareness of protocols dealing with child sexual exploitation and trafficking in children cases.

Molo Songololo was also contacted various educational presentations at the events of partners focusing on: -

- The Rights of the Child
- Child sexual exploitation – myths & reality
- Trafficking in children – nature and extent
- Online sexual exploitation of children
- Child Rights Practice Standards

Molo Songololo also took part in various webinars on child rights issues, and made presentations on the following,

- The role and function of the Western Cape Commissioner for Children
- The Children's Act Amendment Bill
- Parental Rights & Responsibilities



## Awareness and advocacy

Public education is vital, to inform the public, community members and service providers about the work Molo Songololo do, as well as child rights and protection issues.

During this reporting year we were able to resume these activities in Atlantis, Beaufort West and Delft. We conducted public education activities with

- School learners and educators at schools
- Community members at service points like the local clinics,
- Libraries and community halls
- Shopping malls

The key awareness and advocacy messages that Molo Songololo Promote focus on the following: -


- The rights of the child to safety and protection
- Prevention of public sexual harassment of children, especially girl children.
- Prevention of child sexual exploitation and trafficking in children
- Prevention of online production and distribution of sexual abuse images of children

Molo Songololo also collaborates and partners with various groups to support their work and public initiatives. They include

During the 16 Days of Action Against Child and Women Abuse Molo Songololo support members of It's Your Move with their campaign **#MoloAgainstCatcalling** in Atlantis, Delft and Beaufort West.

Over 5000 people attended our public education sessions that aim to inform and advocate for good practice standards for childcare and protection.
