When you signed your lease with the Sault Ste. Marie Housing Commission, you agreed to an extensive list of "requirements" to obtain and keep your subsidized housing. Subsidized means that a portion of your rent is paid for by the federal government, based on your income. Housekeeping is extremely important. HUD has set what is considered "acceptable" housekeeping and what is not. A complete list of what HUD requires is listed in your lease.

We understand that there are a lot of rules and requirements associated with federally subsidized housing. HOWEVER, in order to get the reduced rate of rent compared to the private landlord sectors rate of rent (*Example: For Chippewa County, a 3-bedroom unit at fair market rent is \$989.00/month*), these requirements have to be met.

When maintenance enters a home, part of their job is to report on the condition of the home, inside and out. They will take pictures as well. If it is substandard per HUD requirements, it is reported to admin and you will get notification of a follow up housekeeping inspection. Sub-standard housekeeping is a lease violation. Three lease violations in a year can result in the loss of your home.

There are agencies and programs that may be able to help if you are unable to keep up on your own. These agencies will be suggested to you during your inspections and we hope that you take advantage of them, if you qualify, for their assistance. ANIMALS/VISITING ANIMALS

Animals can be a great addition to any household. However, they come with added responsibilities and expenses. Please keep the following in mind if you are considering one.

- You must have approval from administration **PRIOR** to getting an animal. This must be requested in writing by completing our Animal Ownership Form and providing the required documentation.
- There is a one-time animal administration fee in addition to a monthly animal fee.
- Animals must be spayed or neutered, up to-date on all vaccinations (proof must be provided yearly), and dogs must be licensed yearly (verification required).
- You must always be present when supervising your animal, cats included. Your animal is <u>NEVER</u> to be left or tied up outside. Animals must be leashed at all times and animal waste must be disposed of immediately.
- Visiting animals must be requested in writing and approved from administration **PRIOR** to the animal coming onto Sault Ste. Marie Housing Commission property. Additional documentation is required.

Be sure to reference your tenant handbook for any and all information in regards to SSMHC's Animal Policy.



The City of Sault Ste. Marie has a specific ordinance for burn pits and they must be followed. According to the ordinance (*sec 12-45*), the fire pit must be no larger than 3 feet by 3 feet square. They must be contained above the ground, in a fire safe pit, and with a screen cover. Only firewood may be burned.

You must present a burn permit from the city to our office **PRIOR** to having a fire. The permit has to be logged in your file. Burn pits must also be posted for random inspection purposes (city/housing). You may lose your privilege to burn if you do not have it on file and it is found at your unit! Any damages caused are the sole responsibility of the tenant.

ANNUAL RECERTIFICATION & INSPECTIONS

When you receive notice that it is time for your Annual, you may wonder why it is 3 months prior to your original move-in month. In order to get your verification's and file processed prior to your annual move-in date, we have to start the process.

Call our office and ask about our current procedure and a time frame in which maintenance can enter your home (you do not have to be present) to complete the annual inspection or the follow-up work order. It is imperative these dates and times are kept.

4 FORMS

Any changes in your household must be reported **within 10 days** of notice. These changes would include: household income, new job or loss of job, pay increase, child support, a minor getting a job, unemployment, social security, disability increase or decrease, pension/retirement earnings, household size, daycare expenses, cash-assistance, etc. Do not wait until your first paycheck. Complete the forms <u>IMMEDIATELY</u> to avoid being charged retro rent, which can add up quickly! You can fax, email, or drop in the secure drop boxes. **You cannot make updates via the phone; a form must be completed.**

WORK ORDERS & LEASE VIOLATIONS

Any damages or work orders not called in as they occur and are found during an inspection are considered lease violations. Per your lease, you are required to call these in. Be sure you do your part and report as they happen so violations do not incur.



- Yard Reminders Children's toys must be picked up and put away every day. This includes any items left at the playgrounds. <u>NO</u> pools, trampolines, sprinklers, or swing sets of any kind. <u>NOTHING</u> is to be attached, nailed, drilled into the structure of your unit or your shed. Trash cans are to be placed in the <u>BACK</u> of your unit.
- <u>HiRise Tenants</u> Bicycles cannot be stored in your unit. They must be parked in the bike rack outside whenever they are not in use.
- Basements Nothing FLAMMABLE can be stored in your basement. The basement is also not a sleeping space! According to local fire codes and housing rules, the basement is not to be used for additional sleeping or as a bedroom space.
- **Car Washing** Washing your car is <u>NOT</u> allowed on the property unless you pay your own water bill.
- Lawn Care Upon lease signing, you were informed that you are responsible for your own lawn maintenance. This includes the trimming of your lawns edges. Whether you cut your own grass, hire someone, or borrow a lawn-mower from someone, it <u>MUST</u> be done. If your lawn does not meet lease guidelines, you will be door tagged and given ample time to meet these requirements. If the SSMHC maintenance staff ends up having to cut your lawn, you will be charged a \$70.00 fee.
