TULSA LAUNCHES DEPARTMENT OF CITY EXPERIENCE

In July, as part of a citywide reorganization, the Working in Neighborhoods Department became the Department of City Experience, which combined several neighborhood-oriented services into a single department, the Department of City Experience (DCE). Based on some research in partnership with Gallup, the City found that residents who said they belonged in their neighborhoods and felt like city leaders heard them were twice as likely to thrive in life. So, the City set out to create a department focusing on designing, supporting, and maintaining neighborhoods where residents felt they belonged and were heard.


DCE now includes the **planning and design** phases of neighborhoods and the public realm between buildings in business districts, the **community development** work to build neighborhood capacity to encourage investment and involvement, and a housing office that ensures adequate, affordable housing. DCE also includes the maintenance and upkeep of private properties through **code enforcement** of zoning, nuisance, and property maintenance codes. DCE is responsible for ensuring neighborhoods are free from stray animals and that animals that come to the City's shelter find homes. And it includes a resilience office that creates a more equitable city by advancing economic and social outcomes for all residents.

Over the next year, DCE's leadership will develop strategic goals and work as a team **to create the best experience possible in neighborhoods throughout Tulsa.** The offices and divisions within DCE are as follows:

HANGING TREE LIMB REMOVAL CONTINUES ACROSS TULSA

City contract crews continue to remove overhanging or unstable branches, limbs, and trees in the right of way or public spaces following the June 18 storm. More than 45,000 hanging branches in the public right-of-way, over sidewalks, and in parks have been identified for removal. Currently, 14,191 have been removed.

The City announced this endeavor in August, and crews anticipate finishing the clean-up at the end of November. The City asks for patience from residents as storm cleanup continues.

The removal of hanging limbs is covered under the federal declaration from the storm, and specific documentation requirements must be followed. Over the past few months, inspection crews have canvassed Tulsa roadways for tree branches and documented any hanging from a tree in the public right of way and in danger of falling.

Crews are using a grid system to collect branches, which will be piled alongside the curb for a followup debris removal crew to collect within two weeks.

To put things into perspective, the 2007 ice storm resulted in roughly 3 million cubic yards of debris, which took 18 months to clean up. In contrast, the current storm is predicted to produce about one million cubic yards of debris. It's important to note that we have only been cleaning up for three months, and the disaster declaration was made one month after the storm.

If you come across hazardous tree limbs in the right of way, you can contact 311 during regular business hours or send an email to Tulsa311@cityoftulsa.org with the location and a brief description of the issue. When you report a tree or limb, it will be added to a list and taken care of as soon as the crew works in the related area.

According to Title 24 Nuisance Code, it is the responsibility of the tree owner to take care of tree limbs that are still hanging and attached, and Code Enforcement will work them as such.
