1. The candidate must be a citizen of India.
2. The appointed person shall only be entitled for salary DA, HRA only. Any other allowances as per approved by the ICAR time to time. If ICAR curtail the grant for pay and allowances, the salary of the Krishi Vigyan Kendra staff will be restricted accordingly.
3. Posts are temporary and are likely to continue as long as sanction of the scheme continuance is available from ICAR. In case of the closure of KVKs, their services shall be terminated automatically, and after the termination of the scheme, the Organization will not absorb the candidate in any capacity.
4. The application form for submission shall be filled in, complete in all respects, giving correct information. Defective and incomplete application and those with wrong or false information will summarily be rejected.
5. No promotion, higher pay scale, up-gradation of pay scale or any other financial benefit (which has not been sanctioned and approved under KVK Scheme of ICAR) shall be granted. NGO will be not be liable to bear any expenditure on pension contribution and/or leave salary contribution or any retirement benefits incurred or committed. Pay, allowances and other emoluments will be given as per the ICAR norms and guidelines.
6. The superannuation age shall be 60 years or as applicable as per the guidelines of the ICAR, time to time. The services, conditions, promotions, upgradation, and age of superannuation will be as per the ICAR guidelines for KVKs
7. The appointed person shall only be entitled for salary DA, HRA only. Any other allowances as per approved by the ICAR time to time. If ICAR curtail the grant for pay and allowances, the salary of the Krishi Vigyan Kendra staff will be restricted accordingly.

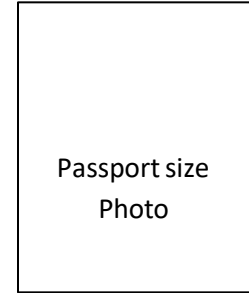
