# **Tech Stuff from CES**

Panasonic: unveiled a 11'x 6.25' plasma TV, that is 150" diagonal. One of the best things about this display is the resolution 4,096 x 2,160 known as 4K, that is twice as many vertical and horizontal lines as 1920x1080. Sony also displayed a 4K set, just not as big.

# **HD** disc

The HD disc format war isn't over yet but it looks like the Sony's Bluray Disc (BD) may win this round. Toshiba, Microsoft and the DVD Forum have not thrown in the towel yet. In the wake of Warner's announcement that in May they would no longer support HD-DVD and will exclusively release on BD the HD-DVD promotions group canceled their press conference at CES. The spokesman for Warner sited lower than expect sales in both HD formats and that having two HD formats has compounded the fear/reluctance of consumers not wanting to end up with the next generation of a Betamax machine. Warner claimed sales of HD disc 60/40 BluRay/HD-DVD.

There is a rumor that Warner received a large chunk of cash for this exclusive offering but both parties deny such deal. In the Fall of 2007 Viacom (parent Co. of Paramount) signed an exclusive deal with the HD-DVD group and they stopped releasing movies on BD. The exact details of the contract weren't released but both parties acknowledge there was about \$150 million in cash and promotion going to Viacom. Sales of Paramount HD disc had been almost 2:1, BD to HD-

# **BD Players**

Denon is shipping a BD transport DVD2500BCTI, and by March 1st we should see a BD player DVD-3800BDCI; MSRP \$999 & \$1,999 respectively. Before you rush out and purchase a transport you should know it is designed to work with a Denon processor, I am not sure what is proprietary about it's data stream. The other part of D&M marketing; Marantz will release their BD player in April for \$2K. These are the first HD-Disc players targeted for Videophiles, At 4 times the cost of current BD players, the Consumer Electronics industry will await sales figures.

# **HD-DVD Xbox 360**

Microsoft lowered the price on the accessory HD-DVD transport for the Xbox360 by \$50 to \$130. As far as I know the 5 movies with the purchase offer is still available.

Kaleidescape; manufacture of the high-end video server system announced it will bring to market a BD capable machine in 2009.

#### 3D TV at CES

Over the last 4 years at CES I have seen numerous versions of 3D video displays. Like usual most mfg have claimed their system would make it to market. Samsung showed their polarized plasma display requiring glasses. Source for the system were 2 games, Need for speed Pro-street and NFL Madden 2008.

Mitsubishi demonstrated a version of 3D that doesn't require any glasses, to acquire the video they used 16 cameras, during playback projectors were mounted in the same configuration. This system utilizes a special lenticular screen. This system is obviously cost prohibitive for home use but may be feasible in commercial displays.
