- Sponsorships and Partnerships




How does California medicinal cannabis and organic produce fit the narrative of MAMS?




- Medicinal cannabis is the only known treatment modality for Multiple Sclerosis (MS).

- This template and platform utilizes cannabis/hemp and fungi as entry crops to restructure the agricultural industry of California into a sustainable model, and acts as the catalyst for the Decarbonization Revolution.

- California agriculture consulting services available.




What does NorCal CGA do?





Marketing, service, and supply cooperatives are the most common types of agricultural cooperatives/collectives organized in the U.S.



What are the characteristics of NorCal CGA?



- Owned by farmer members.
- Dramatically controlled by the farmers who own and use the business.
- Economic benefits are distributed to members based on the member's use of the cooperative/collective.
 - Provide benefits to producer-members as users, not as investors.



What are the goals of NorCal CGA?



- This template and platform was designed for the legal, collective monopolization of the California cannabis/hemp, fungi/mycelium, and organic produce industry.
- Land acquisition through endowments. Land Trust.
- Implementation and management of the Sustainable Collective Organic Fractal Farming model.
- To return to a symbiotic homeostatic, relationship with the biosphere that is interconnected at every level.
- To transform the "toxic" mono crop, petrochemical based, unsustainable system, into a sustainable collective/cooperative model.
