# BABY GRAND MUSIC INSTRUCTION, LLC (BGMI) ACCOUNT AND STUDIO POLICIES ~EARLY CHILDHOOD MUSIC AND MOVEMENT CLASSES~

#### **Schedule and Class Exceptions**

- Baby Grand Early Childhood Music and Movement classes will be held on a weekly basis on a given day and time unless
  otherwise noted.
- \*\*\*IMPORTANT\*\*\* There is no credit for classes missed due to absences. If a class is missed due to the fault of the student, the instructor is not required to offer a make-up class or give monetary credit. Credit will not be given for classes missed due to school closings, inclement weather or unforeseen circumstances unless approved by Meleah Farlow, however, if the teacher at BGMI is responsible for the missed class, the class will be rescheduled at a time that is convenient for both the instructor and school or a credit will be given to the account.
- There will be no classes held during the weeks of Thanksgiving, Christmas, and Spring Break and one week during the summer, however, due to months with 5 lessons, the student will still receive the appropriate number of classes throughout the year.
- Please do not send your child to lessons if they are feeling sick or showing symptoms of any sickness. We understand that this
  may feel like a loss of money, but it is best to avoid spreading illnesses to teachers or other students.

#### Payments, Fees and Additional Costs

- On the 15th of the month, an invoice will be sent to you via email for the upcoming month's tuition. This payment will be due on the 1st day of the upcoming month. (Example On January 15th, February's invoice will be emailed or mailed to you and payment will be due no later than February 1st.) If your email address is not available or you would prefer to have your statement mailed to your home address, an invoice will be mailed to you upon request.
- As of August 2023, payment is \$48 per month for Early Childhood Music and Movement Classes.
- Preferrable payment is through Automatic Debit. This option is available through the QuickBooks invoice that you will receive,
  or you may fill out the form that is available on our secure site babygrandmusic.us.

Other options include:

- o Pay Online from the invoice you receive via email.
- o Call (336) 259-5162 and make a payment over the phone.
- o Mail your payment to: Baby Grand Music Instruction, 1607 Jubilee Trail, Kernersville, NC 27284.
- o If no payment is received within 60 days, lessons will be discontinued, and your account will be charged a \$25 service fee and sent to an outside collection agency.

### Withdrawal Notice

• If you must withdraw your child from class, a 30-day written notice is required. If notice is not given, BGMI, does reserve the right to charge the full month's tuition.

## Class/Lesson Waiver

I understand that my child(ren) may be working with musical instruments, props (such as various rhythm instruments, drums, sticks, scarves, parachutes, streamers, etc), physical movement and dance, along with other music-related activities. The previously mentioned items may be associated with accidental trauma due to force, entanglement, falls, etc. Although these risks are extremely low in these circumstances, I do understand the nature of these activities and hereby assume any and all risks associated with these activities. My child has my permission to participate in BGMI classes and by signing below, I release any claims, damages and liabilities arising from or related to my child's participation in this program.
