BID AGREEMENT FORM

BID AWARD: Bids will be reviewed, and awards made or bids rejected at the sole discretion of the Seller (AR International, LLC). The successful bidder will be notified by telephone and email.

PAYMENT AND REMOVAL OF ITEMS: Upon bid award, buyer will have 72 hours to make payment in full. Payment may be made by company check, certified or cashier’s check, credit card or wire transfer. Full payment must be received prior to removal. The items are to be removed at the buyer’s expense no later than 2 weeks after receipt of payment and the issuance of a bill of sale by Seller. Buyer agrees to provide all necessary equipment, licenses, permits and liability insurance to comply with any removal requirements. Buyer further agrees to indemnify AR International, LLC, its agents and employees from and against any claims, damages, losses and expenses, including but not limited to attorney’s fees arising from the removal of purchased items.
