Even though we no longer sacrifice animals or follow the dietary codes of Leviticus, God's law still speaks:

- ✅ **It reveals God's holiness** – The law teaches us who God is and what He values.
- ✅ **It exposes our sin** – No one can keep the law perfectly (Romans 3:20). It shows our need for grace.
- ✅ **It points to Christ** – The sacrifices and rituals of the Old Testament foreshadow the ultimate sacrifice: Jesus (Hebrews 10:1-18).
- ✅ **It guides Christian living** – While we're not bound to the civil and ceremonial laws, the moral law remains a reflection of how we should live in Christ.

In Christ, we are not **lawless**—we are **grace-covered**. The difference? The law once **condemned us**, but now, through Jesus, it **compels us** to love and obey God from the heart.
