

CLS MARKET BROILER DIVISION RULES AND REGULATIONS

1. This division is subject to the CLS General Rules & Regulations and these Division Rules & Regulations.
2. All exhibitors must abide by all rules and regulations to be eligible to show.
3. Market Broiler pens will consist of three birds.
4. Any substitution of broilers (use of alternate) must be done before check-in. The first three broilers turned in to the sift judge (or in the case of no sift judge, the committee chairman or designated person) are the broilers entered and no substitutions will be allowed after check-in.
5. Each bird will be sifted at the check-in by a sift judge/designee by the broiler chairman.
6. Sifted and/or disqualified chickens and/or pens can not be sold in the freezer sale.
7. Exhibitors will be notified electronically of the location, time, and date for broiler pick-up. There will be a minimum of 25 chicks per order per exhibitor. A representative of the exhibitor or the exhibitor will be responsible for listing the band number on each chick. They will then sign and return the list to the chairman at the time of delivery.
8. All exhibitors in the same family unit may enter broilers as a family unit group. Then an exhibitor may show any three of the broilers that were banded in his/her family unit group. An exhibitor must abide by all other rules to be eligible to show.
9. On the day of check-in at the show, band numbers will be checked with the list the exhibitor signed. Wrong numbers will be cause for sifting. All birds must have bands in their wings.
10. The judging area will be closed off during the judging.
11. Holding pens will be provided for Grand and Reserve pens ONLY. The exhibitor is responsible for providing feed pans and water. The exhibitor is responsible for feeding and watering these animals the ENTIRE TIME they are on the grounds.
12. Amount of Pens Sold – See Premium Auction Rules.
13. Non-sale broiler pens will be released after judging and must be removed by the time specified on the Schedule of Important Dates & Deadlines.
14. The exhibitor is responsible for delivering sale pens of broilers to the Buyer in accordance with the Buyer's instructions. **DO NOT PROCESS SALE ANIMALS (PREMIUM OR FREEZER SALE) PRIOR TO HAVING BUYERS' DELIVERY INSTRUCTIONS. SOME BUYERS WANT LIVE CHICKENS.**
15. All Broilers sold through the Youth Auction or Freezer Sale must deliver birds to the buyer, per their instructions, as stated on the Poultry/Rabbit Delivery Form (within 14 days of the sale).
 - a. It is the exhibitor's responsibility to obtain buyer information after the sale.
16. Exhibitors are responsible for submitting a signed Poultry/Rabbit Form within 14 days of the Auction. This form can be found on the website. It should be emailed to clevelandlivestockshow@gmail.com
