I. Hours and Setup

- a. Mayfest's Vendors hours are, rain or shine (Absent exigent circumstances such as a pandemic or natural disaster, a "force majeure" event), are 9:00 AM to 7:30 PM.
- b. Vendors are eligible to begin set up at 7:30 AM on the day of the event.
 - i. All vehicles associated with set up and not otherwise excepted (eg: food trucks) must be removed from the event space by no later than 8:30 AM.
- c. Food truck vendors are requested to be on site by no later than 8:00 AM.
- d. Booth tear-down (Removal of Vendor booths and vacating of the space) begins at 6:30 PM. To facilitate this, all streets associated with Vendors are closed until 7:30 PM
- e. The Mayfest Committee does not provide support for set-up and tear-down and as such, it is the obligation of the Vendor to supply all requisite staff, site support, and necessities.

II. Fees

- **a.** All fees are payable to Lovettsville Mayfest Committee.
- **b.** A \$25.00 Non-Refundable application fee is required for all Vendors.
 - **i.** This \$25.00 application fee is for Vendors who wants to sign up for a space at the Lovettsville Mayfest event.
- **c.** All Vendor fees are non-refundable once a Vendor is notified of acceptance by the Committee.

III. Compliance with Laws

- **a.** All Vendors are obligated to comply with any applicable licensing or inspection requirements associated with their offerings.
- **b.** The Lovettsville Mayfest Committee may request to view any relevant business documentation such as health code permits, business licenses, or certificates of good standing for any Vendors.

IV. Taxes

- **a.** Vendors are obligated to remit any and all applicable taxes to the relevant authorities in connection with this event.
- **b.** Food Vendors are on notice that the Town of Lovettsville charges a 3% meals tax on all food and beverage sold in the Town of Lovettsville. Food Vendors agree to provide (i) verification of their net proceeds for food and beverage on the day; and (ii) payment to the Town of Lovettsville on the net proceeds for food and beverage sold the day of the event.

V. Mayfest Committee Discretion

- **a.** The Lovettsville Mayfest Committee reserves the right to reject a Vendor at their discretion.
 - i. Vendors whose products or offerings are deemed incompatible with a family friendly atmosphere or whose offerings are redundant to other offerings may be rejected.
 - **1.** In any event, the Lovettsville Mayfest Committee's policy is to encourage as many Vendors as possible to provide as diversified and rich an event for guests as possible.
