<u>Directories.</u> Directories are being finalized...November 1 was our input cut off. They will be distributed electronically to those for whom we have email addresses, and in print for those we do not. Email's save us distribution and printing costs!

<u>Rules and Regulations.</u> The Rules and Regulations document has been distributed with the summary of changes provided. Please observe them for all our benefit.

Neighborhood Watch. Based on limited feedback from our residents, the Board decided to go informal, meaning if you see a problem you call the police. New signage has been posted at our entrances. Note, we have had reports of very prompt police response to our phone calls, don't hesitate to call them with anything that seems out of the ordinary.

Security Camera. The Board is pursuing installation of a

security camera at our entrance on Barbara to capture all vehicles entering and leaving. We'll notify you when it is active.

Pool Operation. The Board decided to keep the pool open and heated beyond our normal closure date of November 1. We recognize that many health club pools are not yet open, and we got a late opening due to the COVID shutdown last spring. We

plan to keep the heater operating until temperatures get too cool. We'll keep it open for any brave enough to use it with only solar heat beyond that time.

<u>Slow Down.</u> Our community has no sidewalks, pedestrians and children may be using the streets. Please slow down, we do not want a tragedy! "Slow" traffic signage has been put up at our entrances as a reminder to all.

Barbara Drive Repairs Update. We requested the City look at the poor condition of street signs on Barbara Drive, and are pleased to report they all have been replaced with new signage. Also, we have been notified that many of the trees that currently line Barbara Drive will be removed because the roots are causing the sidewalks to heave.

For each tree the city removes, they will replant a tree. And because this will occur next year, we have postponed our approved project to refresh the landscaping on Barbara Drive near the entrance until the city completes their work.

<u>Architecture.</u> Happy autumn Woodridge! Our neighborhood is looking great going into the fall season. Here is some fall home maintenance tips that you may want to consider:

- Install fresh batteries in smoke/carbon monoxide detectors
- · Test and dust all detectors
- · Check fire extinguishers
- · Clean kitchen exhaust hood and filter
- · Drain sediment from hot water heater
- Vacuum refrigerator coils
- Insulate exposed pipes as needed
- Schedule furnace inspection
- Have chimneys and flues inspected and cleaned
- · Inspect the roof for damage
- Clean gutters

The architecture committee has been working with some very helpful neighbors to develop a new paint palate with the help of a color specialist from Dunn Edwards. We found that the original colors were no longer available and becoming hard to match, resulting in colors that were not on the palate. We also noticed that quite a few of our neighbors who, with Board approval, have already moved toward a neutral palate and wanted to update our selections to reflect their taste as well. Although we tried our best to choose colors that would blend together, we found in the end that we needed to respect the desires for both the new and old colors.
