I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and waiver of claims and sign it of my own free will. Inclusive in this agreement and published in RRS 2024-2028.

RRS 2024-2028 Rule 3 states: 'The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.'
