I further expressly agree the foregoing release and waiver is intended to be as broad and inclusive as is permitted by law and that if any portion, clause or sub-clause hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and waiver of claims and sign it of my own free will. Inclusive in this agreement and published in RRS 2021-2024.

22.1 RRS 2021-2024 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury.
