Dear Law Enforcement Official:

I would like to file a complaint that my 14th amendment rights providing for equal protection under the law have been violated. Please find enclosed evidence of use of fraudulent voting machines in 69 counties in Michigan. While our community may not use Dominion Voting Systems, the fact that they are used in the state and may result in incorrect results impacts not only the voters in counties using Dominion machines, but all the voters in the state and across the nation. Below is an explanation of the enclosed evidence:

- Please watch the video found at: https://www.youtube.com/watch?v=33rlY3b5DSQ. This 19 minute video provides a summary of the contents of much of the materials included in this packet. The first 8 minutes and 54 seconds discuss the Fox News v Dominion lawsuit. The remaining time discusses Dominion voting machines issues and evidence relevant to my complaint.
- 2. The file 2- Barry_County_Dominion_Files.zip includes the Dominion documents recently sent to Congress by Barry County Sheriff Dar Leaf. While there are many relevant documents enclosed, I highlight the document file 340-342.pdf which calls out Serbian Dominion employees remotely accessing the state of Colorado system to 'test' it. This indicates that voting machines are remotely accessible.
- 3. File 3- is Barry County Sheriff Dar Leaf's letter to Congressman Jim Jordan regarding Barry County's investigation. In the letter Sheriff Leaf indicates "foreign nationals have accessed electronic voting machines in Michigan and other states."
- 4. File 4- Macomb...pdf is a copy of a complaint filed in the Macomb County Sheriff's office indicating that Dominion CEO John Poulos committed perjury during his testimony to the Michigan legislature.
- 5. File 5- Is a statement from an expert witness during the Antrim County, MI case. Benjamin Cotton of CyFIR, LLC. states that during his forensic examination of the

Dominion Voting System images IP addresses were identified that can be traced back to Taiwan and Germany. In addition to the remote access Mr. Cotton also describes the presence of a wireless communications card and outdated security measures on the tabulator. 6. File 6- Email...pdf is a November 12 2020 email from J Alex Halderman offering assistance to Dominion Voting Systems. In accordance with Michigan law 168.797c, tabulator source code is to be held in trust at a state level. J Alex Halderman PhD, Professor of Computer Science and Engineering, University of Michigan was cochair of the Michigan Election Security Advisory Commission established by SOS Benson in 2019. In October 2020 the Commission recommended that tabulator source code be subject to "source code security audits and penetration testing" at least annually. Not only was the testing not completed but in interrogatories (sworn under oath) from the Antrim County, MI case it was learned that SOS Benson never possessed the source code in trust. So during the Antrim County, MI case, Mr. Halderman – co-Chair of the Commission and person likely to conduct security testing - had a personal interest to bury 2020 evidence. It is believed that Mr. Halderman took Dominion's version of events as true and specified that the Plaintiff's expert witnesses regarding vote shifting was false. Mr. Halderman would later be an expert witness in the Curling case in Georgia where he would demonstrate the feasibility of altering election results on Dominion Voting Systems (See File-8 and 9 below).

Just as concerning, it was also learned during Antrim County, MI testimony that SOS Benson was unable to answer questions regarding voting machines and referred all questions to Dominion. This demonstrates a reliance on the vendor for trust and transparency which we now know does not exist (Refer to File 4 above on Polous perjury).

- 7. File 7- CISA....pdf is a June 3, 2022 acknowledgement from the US Cybersecurity & Infrastructure Agency that issues exist with Dominion Voting Systems Democracy Suite Imagecast X machines. These machines are used in Michigan.
- 8. File 8- BREAKING...pdf is an article from The Gateway Pundit which describes J. Alex Halderman PhD, altering the elections results on a Dominion Voting System during his testimony in a Georgia election case.

- 9. File 9- gov....pdf is J Alex Halderman's PhD report related to the Georgia election case.
- 10. File 10- 2024....pdf is the Lake v Fontes brief filed with the United States Supreme Court in March 2024. The brief indicates that passwords were left unencrypted in the Dominion source code easily allowing for access.
- 11. File 11- Presidential Race.....pdf which documents that 69 Michigan counties use at least 1 Dominion tabulator and an estimated 52.9% of votes cast in Michigan were tabulated on Dominion Democracy Suite Imagecast X machines. Similar percentages of the Michigan vote tally should be expected in the 2022 and other elections.
- 12. File 12- Biennial...pdf which is from the Michigan Department of State Bureau of Elections and documents machine brand use across the state.
