The VM is located in the FTP \_employee public folders/rmorales/CITY\_RTM (Remote88!)

The process to connect is as follow:

- Click the VPN App (NCP Exclusive Entry Client), icon in the desktop and taskbar.
- In the app, click the red rectangle in the connection area (right top), the “connection established” message should appear in few seconds.
- Open the Remote Desktop icon in the taskbar, then, click connect... the connection settings are already pre populated.
  - The connection is going to be established with the listener monitor station, and from there you can remote into the servers that you need to connect.

In the desktop of the VM, there is a file called users\_city, in it, you will find the credentials of the remote computer, along with server credentials.

Tomorrow, I will work with the CITY IT in order to get access to the ICC stations, although, seems like they are still scanning ballots, so, we are going to do it in best way without interrupting too much their work.

The VM was uploaded couple hours ago, however, the filezilla still shows 100% with second left....
