Meeting Minutes

The Fairwood Crime Prevention and Improvement District ("District") held a meeting at Fairwood Branch Library, Thursday, April 21, 2022.

The meeting was called to order by Chair, Scott Giurintano at 6:30 p.m.

Approval of minutes

Motion was made by Scott Giurintano and seconded by Melanie Sims to accept minutes from the March 17, 2022, meeting.

The motion passed unanimously.

Treasury Report

Expenditures for the past month totaled \$1,550. This included payments for lawn service and security patrol. Income for the past month was \$208.88 for parcel fees. The current balance is \$25306.71.

Motion to approve the report was made by Pat Cormier and seconded by Lloyd Gavion.

The motion passed unanimously.

Website

Pat Cormier can now access the website, www.fairwoodcrimedistrict.org, to make changes and updates. He has added several months' of minutes that can be accessed by the month. He will continue to keep the website up to date.

Flock Security Cameras

Between March 23 and April 21, 2022, there were 132,500 license plates read. The highest daily reading was Saturday, April 2, 2022. During this time one camera failed. A new camera was ordered and will be installed, though the current camera did restart.

There were 14 users of the system – 7 by the EBR Sheriff's Office and 7 by the Baton Rouge Police.

No arrests were reported. There were 22 hits on the hot list.

Installment of the two new cameras at the intersections of Millerville and Spring Ridge and at Millerville and Deer Ridge are still pending completion of the permitting process.

Security Patrols

In March, there were 25 hours of security patrol. The time was spread over nine days, with times ranging from 3:00 pm to 1:00 am. During that time, citations were written for 16 stop sign violations, and one parking violation warning was issued.

Security Incidents in the District

Pat Cormier reported a total of 8 calls for assistance between March 1 and March 31, 2022. This included five calls for alarms activated, 2 calls for medical assistance, and one call for a missing adult.

Neighborhood Watch Committee

Thomas Shuff reported the following:

- A neighborhood Watch Meeting was held on March 17, 2022.
- We have one new block captain; she questioned the possibility of getting speed bumps on S. Flannery.
- A committee meeting is scheduled for June 23, 2022. The topic has not been decided.

Adjournment

Pat Cormier made a motion to adjourn the meeting at 7:07 p.m., seconded by Lloyd Gavion. The motion passed unanimously.
