Appointment of Special Counsel

Resolution to Call a Special Election to Authorize a Parcel Fee

Motion was made by Scott Giurintano to adopt a resolution to call a special election to levy a \$40.00 per year parcel fee for residential owners and \$200.00 for commercial owners, to apply to the Louisiana State Bond Commission for approval to levy the fee, and to submit a ballot proposition to the Louisiana Secretary of State for an election on Saturday, November 16, 2019, seconded by Lloyd Gavion.

The motion passed unanimously.
