The Fairwood Crime Prevention and Improvement District ("District") held a meeting on Thursday, July 17, 2025.

The meeting was called to order by Commissioner Scott Giurintano at 6:39 P.M.

## **Approval of the Minutes**

A motion was made by Pat Cormier to approve the minutes from the May 15, 2025 meeting. This was seconded by Lloyd Gavion and passed unanimously.

## **Treasurer's Report**

The District received \$183.87 in parcel fees from the EBR Sheriff's Office for June and July 2025, and \$97.90 in interest for July 2023 through June 2024 from the East Baton Rouge Parish Sheriff's Office. Since the District's May 15, 2025 meeting, expenses totaled \$9,559 and included the following: \$1,650 for lawn maintenance, \$1,400 for security patrol, \$5,525 for Flock security cameras, and \$984 for insurance. The current balance is \$16,599.90.

Financial Statements were submitted by the District to the Louisiana Legislative Auditor on March 10, 2025.

Scott Giurintano moved to approve the presented report. The motion was seconded by Pat Cormier. The motion passed unanimously.

## Flock Security Cameras - May 2025

During May 2025, there were 179,040 license plates read. South Flannery at Old Hammond had the highest volume day (3,746 vehicles) and Pecan Ridge saw the lowest volume day with 33 vehicles. 74 of the plates read were on the "hot list."

## Flock Security Cameras – June 2025

During June 2025, there were 173,302 license plates read. South Flannery at Old Hammond had the highest volume day (3,366 vehicles) and Pecan Ridge saw the lowest volume day with 32 vehicles. 320 of the plates read were on the "hot list."

### **Security Patrols - May 2025**

In May 2025, there were security patrols every 6.2 days, with times ranging from 10:30 P.M. to 6:00 A.M. During this time period, the officer issued 5 stop sign citations. The officer patrolled the house fire, and worked 20 hours.

## **Security Patrols - June 2025**

In June 2025, there were patrols every 6 days, with times ranging from 3:00 P.M. to 6:00 P.M., and 8:00 P.M. to 5:00 A.M. During this time, the officer issued 5 stop sign citations. The officer worked 20 hours

## **Security Incidents in the District - May 2025**

For May 2025, the following security incidents were noted as provided by Open Neighborhood BR: 1 vice, 3 thefts, 1 drug, 1 traffic, and 3 others. There were 32 calls placed to 311.

## **Security Incidents in the District - June 2025**

For June 2025, the following security incidents were noted as provided by Open Neighborhood BR: 2 thefts, 1 property damage and 8 others. There were 49 calls placed to 311.

#### **Adjournment**

A motion was made by Scott Giurintano and seconded by Lloyd Gavion to adjourn. This passed unanimously, and the meeting adjourned at 7:04 P.M.
