The Fairwood Crime Prevention and Improvement District ("District") held a meeting on Thursday, May 15, 2025.

The meeting was called to order by Commissioner Lloyd Gavion at 6:30 P.M.

The following Commissioners were present: Lloyd Gavion, Patrick (Pat) Cormier, and Melanie Sims

The following Commissioners were absent: Scott Giurintano and Kathleen (Kathy) Allen

Two members of the public were in attendance.

Approval of the Minutes

A motion was made by Pat Cormier to approve the minutes from the March 20, 2025, meeting. This was seconded by Melanie Sims and passed unanimously.

Treasury Report

The District received \$300.58 in parcel fees from the EBR Sheriff's Office for April and May 2025. Since the District's March 20, 2025, meeting, expenses total \$3,050.00 for lawn maintenance (\$1650.00) and security patrol (\$1400.00). The current balance is \$25,877.13.

Pat Cormier moved to approve the treasurer's report. The motion was seconded by Lloyd Gavion. The motion passed unanimously.

Flock Security Cameras - March 2025

During March 2025, there were 192,885 license plates read. South Flannery at Old Hammond had the highest volume day (3,424 vehicles) and Pecan Ridge saw the lowest volume day with 26 vehicles. 31 of the plates read were on the "hot list."

Flock Security Cameras – April 2025

During April 2025, there were 203,024 license plates read. South Flannery at Old Hammond had the highest volume day (5,501 vehicles) and Pecan Ridge saw the lowest volume day with 27 vehicles. 42 of the plates read were on the "hot list."

Security Patrols - March 2025

In March 2025, there were security patrols every 5.16 days, with times ranging from 12:00 A.M.

to 4:00 A.M. and 12:00 P.M. to 4:00 P.M. During this period, the officer issued 5 stop sign citations and 1 parking violation. The officer worked 20 hours.

Security Patrols - April 2025

In April 2025, there were patrols every 6 days, with times ranging from 12:00 P.M. to 5:00 A.M. During this time, the officer issued 5 stop sign citations. The abandoned vehicle has been removed. The officer responded to a break-in which was later discovered to be the homeowner's kids climbing in through a window. No arrest was made. Soon after another call came in about a dead body behind Chillis later discovered this was a prank call. One arrest was made. The officer worked 20 hours.

Security Incidents in the District - March 2025

For March 2025, there was 1 junk car reported, 1 suspicious person, 1 suspicious incident, 1 neighbor trouble, 1 public service rendered, 1 identity theft, 1 shop lifting, and 2 disturbances. There were 37 calls to 311 and 3 permits.

Security Incidents in the District - April 2025

For April 2025, there were 4 others and 22 calls to 311.

Public Comments

There was one inquiry about whether there are any rules on renting homes in the neighborhood. There are no rules, but anyone with an airbnb must obtain a permit from the City.

Adjournment

A motion was made by Pat Cormier and seconded by Melanie Sims to adjourn. The meeting adjourned at 7:10 P.M.
