Please Read This Page Fully & Completely

Any Vendor Who Disregards Any of the Rules or Guidelines listed below will FORFEIT Their Deposit, and WILL NOT be invited to Return.

- Every Vendor is required to Check-In prior to entering and setting up in their designated space. Any vendor who does not check in will not be allowed to set-up their display and will forfeit their rental fee.
- We CAN NOT guarantee exclusivity of Vendors, Displays or Location.
- All Vendors must REMAIN in place until SUNDAY (5:00pm) close of the Fair or will forfeit their Security Deposit
- Any Vendor who will be CONSTRUCTING any type of display will be required to contact the Commercial Vendor Department (GrangeFairVendors@gmail.com) for further instructions from the Fire Marshal. These displays must be in place 48 hours before the start of the fair for inspection.
- Any Vendor supplying their own tent must have a Certificate for Proof of Fire Retardancy. Our Fire Marshal will not allow unsafe tents to be used. We do NOT provide lighting for personal tents not rented from our tent company. Lighting must meet the Fire Marshal's Approval. All ELECTRIC is First Come, First Served.
- All Vendors must supply their own HEAVY DUTY Extension Cords. Light duty cords are NOT acceptable.
- All vendors are responsible for making sure that their space is maintained in a professional and orderly manner. And is returned to the same condition that it was before the Fair.
- Please remember, the attractiveness of your display is not only a reflection of yourself and your business, but our event as well. The Fair Committee reserves the right to remove any and all objectionable material at their discretion.
- All Vendors MUST remain within their display space and guidelines. NO handing out of material outside of designated vendor space.
- NO Raffles may be Held by Contracted Vendors.
- Harassment of other vendors or fair patrons will absolutely NOT be tolerated and will result in immediate expulsion.
- NO Selling, Sampling or Dispensing of food, soda &/ water beverages. Special circumstances may be granted by the Fair Committee and the Board of Health ONLY.
- NO demonstration of Power Equipment and or running of Generators are permitted by commercial exhibitors for safety and insurance reasons.
- NO propane tanks or gases are permitted without pre-approval from Fair Committee. All approved MUST be provided by the Middletown Grange Fair Approved Supplier ONLY.
- Every vehicle entering the premises during the hours of the fair, even before 10am is required to pay the \$20.00 Admission Fee, if they do not have a parking pass in their possession. Vendors are responsible for purchasing additional passes for their employees or for reimbursing their employees, whichever they so desire. We will not handle this issue for you.
- All vehicles that are not parked in a designated parking lot by 9:30am each day will be towed at the Owner's expense. The roads / driveways within the Fair are for pedestrian traffic only. No vehicles or equipment are allowed to be driven or moved within the Fair at any time during Fair hours.
- NO DOGS are allowed on the Fair Grounds. ONLY LICENSED & Documented GUIDE DOGS are permitted.
- NO Alcoholic Beverages are permitted on the Premises.
- Any Vendor who does not have their space completely paid for & have all paperwork properly completed and submitted by July 20, 2022 will NOT be permitted to participate in the Fair.
- ANYONE who violates any one of our rules or guidelines will be given a warning, unless the issue warrants immediate attention. If determined by the committee that the vendor or display should be removed, it will be removed promptly, even without warning.
