JUDICIAL REFORM: JUSTICE BELONGS TO THE PEOPLE

Nevada's courts have operated in the shadows for too long. Power has been concentrated in the hands of a few, insulated from the people they serve. Families are torn apart in secret hearings, small businesses lose everything without fair process, and judges answer to no one. That ends under my leadership.

INDEPENDENT CITIZENS' OVERSIGHT COMMISSION

Independent Citizens' Oversight Commission: The current self-policing system will be abolished and replaced with a civilian-led oversight commission with subpoena power. This commission will be made up of **civilians who have been directly harmed by systemic failures**, because those who have survived the broken system know exactly what is fractured, and how it must be repaired. Citizens will have the explicit right to file complaints directly to the commission, investigations will be fully **public and independent** and will not be controlled or concealed by judges or court insiders. Findings will carry legal weight and lead to **real consequences**, including **suspension, removal from the bench, or referral for prosecution** when misconduct rises to statutory or constitutional violations.

TERM LIMITS AND PUBLIC PERFORMANCE REVIEWS

No judge should serve indefinitely. I will end lifetime appointments and implement **TWO-year terms**, with **public performance scorecards** and retention votes based on reversals, ethics records, timeliness, and trust ratings. Judges who lose the confidence of the people won't stay on the bench.

REAL TRANSPARENCY IN THE COURTS

Every hearing will be **recorded and archived** for public access. Judges will **disclose relationships, donors, and financial interests**, with violations carrying real penalties. A **public online portal** will give Nevadans instant access to disclosure records, complaint histories, and performance data. No more decisions made in the dark.

ACCOUNTABILITY WITH TEETH

When judges knowingly violate rights, people should have recourse. I will back legislation allowing **civil damages against judges** for egregious misconduct and provide **whistleblower protections** for those who expose abuse. No one who speaks truth should face retaliation.

Upon this law taking effect, any corporate or foreign entity currently holding Nevada residential property will be required to **sell that real estate back, directly to Nevada residents, within one year** of the prohibition passing. Nevadans deserve first access to Nevada homes, first benefit from Nevada resources, and first priority in Nevada's future.

Housing exists for humans, not hedge funds. Homeownership exists for families, not monopolies. Nevada belongs to Nevadans. Period.

REAL HOMEOWNERSHIP, NOT PERMANENT RENTING
