Usually, a power of attorney is sufficient to allow someone to sell the house on your behalf if you cannot attend a closing. An outright transfer to a spouse when you may be subject to civil lawsuits or criminal acts is often challenged as a fraudulent conveyance, a conveyance designed to shield the asset from being available to creditors.
