FIRST AMENDMENT TO DECLARATION OF COVENANTS AND CONDITIONS

WITNESSETH:

COUNTY OF HARRIS

WHEREAS, Fidelity Bank and Trust Company, a Texas Banking association (hereinafter called the "Fidelity"), executed that certain Declaration of Covenants and Conditions, on May 13, 1977 (hereinafter called the "Declaration"), which Declaration was filed for record in the Official Public Records of Real Property of Harris County, Texas, on May 17, 1977, under File No. F144256, and recorded under Film Code Reference no. 165-10-1155, and

WHEREAS, the undersigned, pursuant to the power granted in Article IV,
General Provisions, Section 3, Amendment of the Declaration, and further pursuant to
Chapter 204 of the Texas Property Code, desire to amend the Declarations as

hereinafter provided.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

THAT, the undersigned, being the record owners (as shown by the Official Public Records of Real Property of Harris County, Texas) of not less than seventy-five percent (75%) of the real property comprising Spindle Top Ranchettes, an unrecorded subdivision of 543.588 acres out of the David L. Kokernot Survey, Abstract No. 39, in Harris County, Texas, do hereby amend the Declaration by:

(1) Amending Article III, Section 2. To read as follows:

Section 2. The purpose of Assessments shall be used for the following:

Maintenance of Subdivision Entry Markers, Neighborhood Directory, Neighborhood

Watch Program, and projects that would require the majority vote of a quorum.

(2) Creating Article V, Use Restrictions, to read as follows: Article V. Use Restrictions

- 1. No lot shall be used for a mobile home park. All mobile and modular housing must be skirted with exterior matching material.
- 2. No lot shall be used as a hog farm, rendering plant or slaughter house. No feed lots shall be permitted.
- 3. No lot shall be used for a junk yard, or automobile graveyard.
- 4. No lot shall be used for any purpose of personal or business which may be offensive by reason of odor, fumes, dust, smoke, noise, vision, vibration, pollution, or which is hazardous by reason of excessive danger of fire or explosion.
- 5. The owner of any lot shall at all times keep the premises in a safe, clean and wholesome condition in compliance with all governmental, health, fire and police regulations, and will remove at his own expense any trash or debris of any character whatsoever which may accumulate on such lot.
- 6. No gas, oil, mineral, quarry or gravel operations shall be permitted on any lot.
- 7. The invalidation of any one of the restrictions herein set forth or the failure to enforce any of such restrictions at the time of its violation shall in no event affect any of the other restrictions nor be deemed a waiver of the right to enforce the same thereafter.
- 8. These restrictions are made for the benefit of any and all persons who may now own, or who may hereafter own, property in such Spindle Top Ranchettes. in addition to the Association, each individual owner is specifically given the right to enforce these restrictions by injunction or other lawful procedure and to recover damages resulting from any violation thereof.
- 9. The record owners of a majority of the square footage of the lots involved may amend a particular restriction.
- 10. Each conditions and covenant herein contained shall terminate and be of no further effect on January 1, 2028, however, at any time prior to January 1, 2028, the then owners of the majority of the area in square feet within such SPINDLE TOP RANCHETTES may by written Declaration signed, acknowledged by them and duly recorded in the Deed Records of Harris County, Texas, extend such restrictions for a period of ten (10) additional years, and this right to extend for and additional ten (10) year periods by the then owners shall exist as long as the owners of a majority of the area in square feet within such SPINDLE TOP RANCHETTES affirmatively vote to so extend them.

This instrument may be executed in multiple counterparts, petitions, and/or ballots, and each counterpart hereof executed by any party shall be deemed an original and shall as to such party constitute one and the same instrument with all other counterparts hereof executed by any party, and shall bind any party signing a counterpart hereof regardless of whether the same or any other counterpart hereof is executed by any other party intending to be or become a party hereto.


