Welcome to Missionview Saddle Club's two day gymkhana. The gymkhana will be held at the Pima County Fairgrounds during the last weekend of the Pima County Fair. Age groups will be as follows: Buckaroo, 10 & Under, with the other age groups being determined the week before the show. The number of riders will determine the number of age groups, with a maximum of the Buckaroo, 10 & Under and 4 additional age groups. The Buckaroo (Lead line/Walk/Trot) age group will run 2 events each day with a maximum of 15 riders. The Buckaroos will receive ribbons and prizes for each event and an overall prize. Buckaroos will not be a timed age group.

Cash and prizes will be paid out for each event and age group, with high point and runner up winners in each age group each day. Cash and prizes will be paid to the top riders for the weekend in each age group. The number of riders in each age group will determine the number of places in an age group. For every 5 riders one place will be paid up to 5th place. **Please help us and submit your entries before the April 13th pre-entry deadline** as age groups will not be changed once set.

Please Note: All horses spending the night at the fairgrounds must be in stalls. You may not tie your horse or set up your own panels within the fairgrounds. NO EXCEPTIONS!!!

All vehicles MUST enter the Pima County Fairgrounds through the Brekke Gate on the north side of the fairgrounds. Directions are I-10 to Houghton Rd. South on Houghton Rd to Brekke Rd. West on Brekke Rd to the Brekke Gate. Once you enter the fairgrounds you will head west. We will have our event in the first arena you come to on the north side of the road.

The events will be run each day in the order listed. However, if conditions, circumstances or arena conditions warrant, they may be changed. This may include eliminating an event(s) or substituting an event(s). All patterns can be found at missionviewsaddleclub.com.

Fairground entrance passes will be mailed out to all pre-entries! All vehicles and individuals entering the fairgrounds for the show must have a pass. Please get your pre-entries in by the April 13th deadline, so that you get the discount with the participant pass(this includes 1 parking pass and 2 general admission passes). All participants that do not pre-enter will have to pay the full daily rate for admission and parking (General Admission \$13 a day, Youth 6-10 \$8 daily, and Parking \$8 a day). Entries will still be accepted the day of the show, but we are trying to get as many riders as possible signed up prior to the April 13th deadline. PLUS THIS WILL SAVE YOU MONEY!!! All monies must be included with your entry.
