## **Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

While the risk of serious illness or loss of life is highest in those 65 years of age and older, persons in every age group can get COVID-19 and encounter severe illness. We should all be thankful that, with rare exceptions throughout the nation, COVID-19 is not claiming our children's lives. Nonetheless, we can never forget that a child with a mild or even asymptomatic case of COVID-19 can spread the infection to others who may be far more vulnerable.

The Cartwright School has put in place preventative measures to reduce the spread of COVID-19; however, The Cartwright School cannot guarantee that your child(ren) will not become infected with COVID-19.

Despite careful attention to sterilization and cleansings, there is still a chance that your child could be exposed to illness at our center, just as they might at your home, grocery store, or playground. Although we have taken measures to provide social distancing, it is not possible to maintain social distancing at all times due to the nature of our business. While exposure is unlikely, we need to make sure you are aware of this assumption of risk.
