Ground Rules

All contestants, parents, guardians, and helpers shall abide by the ground rules and event rules of the junior rodeo.

Contestants, parents, and helpers must always wear Western attire during the performance while within the following areas of the rodeo grounds: bucking chute areas, roping box area, and inside the arena. Western attire means a cowboy hat, long-sleeved western shirt, full length trousers, and western boots.

All contestants who have horses available are requested to participate in the Grand Entry and line up at 8:45 AM.

No person shall be allowed in the arena during a rodeo performance unless entered in event or assisting a contestant during their performance. Contestants must keep clear of the arena and only be in the arena during their performance. Exceptions will be given for the Midget Division timed events, where another individual may assist the contestant during their performance in the rodeo arena. The assistant shall inform the Arena Director about this arrangement prior to the contestant entering the arena.

Upon completion of the contestant's competitive run, such contestant must immediately leave the arena. All assistants must immediately leave the arena after they have assisted a contestant.

If a contestant is not prepared to compete when called upon in order within three (3) calls, his or her stock will be turned out. The order of rodeo events or the running order of contestants may be changed or rescheduled, for cause, under the direction of the Arena Director.

Only a contestant or a parent will be allowed to register complaints; provided such an objection is lodged to the Arena Director prior to the beginning of the next event.

No contestant or parent may initiate a conversation with a judge or timer in any capacity while an event is ongoing. Contestants or parents may pose questions to a judge or timer at the end of the event, but prior to the beginning of the next event.

Contestants, parents/guardians, and all who attend, shall:

- not quarrel, or be involved in an altercation on the rodeo grounds
- not attempt to threaten, influence, or harass the rodeo officials at any time during the rodeo
- not be under the influence of alcoholic beverages, narcotics, or non-prescribed drugs while on the premise of the rodeo grounds

The decision of the judges, timers, and Arena Director shall be final.

Duties of the Arena Director

Assure that the rodeo is conducted in accordance with the Ground Rules posted, ensure an efficient, and safe production process, and reasonably fair competition for all contestants.

The Arena Director and judges shall meet before the rodeo for the purpose of discussing their respective events and judging procedure.

Inspect the stock prior to the rodeo and the arena condition to ensure fair and safe competition. The Arena Director may declare an animal unsatisfactory. Upon notification, either written or verbal, the stock contractor shall remove such animals from competition and removed from the draw for the duration of the rodeo. The decision of the judges, flagmen, or timers will be final; and no protest or complaint by a contestant/parent will be permitted unless first lodged through the Arena Director. Such a protest must be made before the end of the event. If the Arena Director determines that the protest is based upon a possible misinterpretation of an event rule, the Arena Director, at the first convenient opportunity, shall describe the protest and the interpretation of the rule upon which it's based to the judge. If the judge agrees that an erroneous ruling was made and the error is correctable, then the judge shall modify the rule accordingly. Otherwise, the decision is final.

Timers

In the timed events where an electric eye timer is used, at least one must be a manually operated stopwatch. Should the electric eye fail to work for one or more contestants during a performance, the manual back-up time will be used for those electronically missed. The electric eye-controlled times will remain unaltered. All times must be recorded and then marked as a no-time if flagged out by a rodeo official (this is in case a protest arises).
