FORMAT: 36 holes of Four-Ball stroke play (net-95% hdcp allowance). Teams play as a field. Field limited to 128 Teams.

HANDICAP: April 1 handicap revision used in accordance with USGA recommendations and Slope Handicap System. Handicap indexes above the allowed maximum index of 23.2 will be adjusted down to this maximum for play in the Four- Ball tournament. The Tournament Chair reserves the right to confirm and adjust any Handicap index.

ELIGIBILITY: One player must be a resident of Georgia and be a member of GWGA. **GWGA member may partner with a NON-resident participant for Four-Ball. NON-resident participant must pay a NON-resident fee of \$35 to participate and must have a valid GHIN number.** Georgia player has until the close of entries, April 5, 2019, to join GWGA.

ENTRY: Enter as a team. No single entries or walk-ins accepted. Complete and mail the Entry Form below. The TOTAL TEAM FEE is \$300 and must accompany the Entry Form. This fee includes the Tournament fee, green fees, cart fees, tournament prizes, tee gift, bag storage and taxes for two days plus range balls for tournament days. Practice Round at the course is available at player's cost for \$35. Call for tee times at 912-635-2368.

Entries must be received by 6:00 PM, April 5, 2019. Acceptance notices will be emailed after close of entry to the team member with lowest handicap index. Tournament roster will be available at www.gwga.org by April 24th. If your team withdraws BEFORE April 12, 2019 at 6:00 PM, \$250 will be refunded. AFTER THAT TIME, NO TEAM FEES REFUNDED UNLESS THERE IS A WAITING LIST.

REGULATIONS: GWGA Tournament shall be in accordance with The USGA RULES OF GOLF and Policies and Procedures established by the Georgia Women's Golf Association.

Competitors shall wear appropriate golf attire. Only non-metal spikes permitted. Cell phones must be turned off on the course.

The Board of Directors reserves the right to approve or reject entries and refund deposited monies at any time before and throughout the competition.

Distance measuring devices measure distance only. The use of devices that measure other conditions that might affect a player's play (e.g. wind or gradient) is not permitted. NO CELL/PDA APPS MAY BE USED.

REGISTRATION: Jekyll Island Golf Clubhouse, GWGA Registration Desk. **Each Team must register by 1:00 PM, Sunday, April 28, 2019.** Emergencies call GWGA Registration (912) 635-2368. An authorized individual may register for contestants, provided they supply all necessary information.

REGISTRATION DESK HOURS: Sunday, April 28, 2019 from 8:00 AM - 1:00 PM

AWARDS: The GWGA Director's Trophy will be awarded to the 1st Place NET winners. 1st Place NET winners and 1st Place GROSS winners will be awarded an engraved prize. All winners will be awarded gift certificates to be redeemed in the Golf Shop at the Jekyll Island Golf Club. Approximately 1/3 of the field will receive awards. HOLE-IN-ONE TROPHY is awarded to the competitor(s) scoring a hole-in-one in the competition.
