**FORMAT:** 36 holes of Four-Ball stroke play (net-95% hdcp allowance). Teams play as a field. Field limited to 128 Teams.

**HANDICAP:** April 12<sup>th</sup> handicap revision used in accordance with USGA recommendations and World Handicap System. Handicap indexes above the allowed maximum index of 30.0 will be

adjusted down to this maximum for play in the Four- Ball tournament. The Tournament Chair reserves the right to confirm and adjust any Handicap index.

**ELIGIBILITY:** Georgia players must be current members of GWGA. **GWGA member may partner with a NON-resident for Four-Ball. NON-resident player must pay a NON-resident fee of \$35 to participate and must have a valid GHIN number.** Georgia players have until the close of entries, April 5, 2021, to join GWGA. Each player must have posted five (5) 18-hole scores in the previous 12 months.

**ENTRY:** Enter as a team. No single entries or walk-ins accepted. Complete and mail the Entry Form below. The TOTAL TEAM FEE is \$300 and must accompany the Entry Form. This fee includes the tournament fee, green fees, cart fees, tournament prizes, tee gift, bag storage and taxes for two days plus range balls for tournament days. Practice Round at the course is available at player's cost for \$35. Call for tee times at 912-635-2368.

**Entries must be received by 6:00 PM, April 5, 2021.** Acceptance notices will be emailed after close of entry to all players. Tournament roster will be available at [www.gwga.org](http://www.gwga.org) by April 22nd. If your team withdraws BEFORE April 19, 2021 at 6:00 PM, \$250 will be refunded. **AFTER THAT TIME, NO TEAM FEES WILL BE REFUNDED UNLESS THERE IS A WAITING LIST.**

**REGULATIONS:** GWGA Tournament shall be conducted in accordance with The USGA RULES OF GOLF and Policies and Procedures established by the Georgia Women's Golf Association.

Competitors shall wear appropriate golf attire. Only non-metal spikes are permitted. Cell phones must be turned on silent on the course.

Distance measuring devices measuring distance **only** allowed. The use of devices that measure other conditions that might affect a player's play (e.g., wind or gradient) is not permitted.

GWGA will post each player's score via Golf Genius.

The Board of Directors reserves the right to approve or reject entries and refund deposited monies at any time before and throughout the competition.

**REGISTRATION:** Jekyll Island Golf Clubhouse, GWGA Registration Desk. **Each Team must register by 1:00 PM, Sunday, April 25, 2021. Emergencies** call GWGA Registration (912) 635-2368. An authorized individual may register for contestants, provided they supply all necessary information.

**AWARDS:** The GWGA Director's Trophy will be awarded to the 1<sup>st</sup> Place NET winners. 1<sup>st</sup> Place NET winners and 1<sup>st</sup> Place GROSS winners will be awarded an engraved prize. All winners will be awarded gift certificates to be redeemed in the Golf Shop at the Jekyll Island Golf Club. Approximately 1/3 of the field will receive awards. HOLE-IN-ONE TROPHY is awarded to the player(s) scoring a hole-in-one in the competition.
