AGENDA ITEM I: WELCOME AND INTRODUCTIONS

AGENDA ITEM II: AMERICAN INDIAN LIAISON UPDATE

Presented by Yvette Salas.

- a. She determined that the program does not need a tribal i.d. number for a child to qualify, only need to give the name of an enrolled family member and the government finds out from there.
- b. Title VII lost two students last month—the families got too fed up with BVSD and moved out of the district.

AGENDA ITEM III: BUDGET REPORT

- a. The Title VII program has only spent \$5,800 so far still, but there are some items that have not come through yet. Yvette will try to meet with Katrina so we can get a more up-to-date account next time.

AGENDA ITEM IV: TUTORING UPDATE AND PLANNING

- c. The number of students receiving Title VII tutoring is now at 4 students with more possibly starting soon.
- d. The professor has decided to tutor our primary students as well as any older ones that might be tutored.

- a. We have 2 buses reserved so that means room for around 80 attendees.
- b. All students will have to turn in BVSD Travel Forms to ride the bus. These forms MUST be signed by a parent or legal guardian.
- c. It was decided that due to the powwow schedule, the program should provide breakfast and lunch for attendees. Lunch will be purchased inside the coliseum to any attendees who would like it. Attendees need to sign up by FEBRUARY 25.
- d. Monique will finalize the flyer so it can be posted asap.

- c. Lacrosse clinic was tabled until a later date as we ran out of time.
