PUBLIC SAFETY TRAINING CENTER Update

OVERVIEW

Since City Council's approval of the ground lease for the Public Safety Training Center, APF has made considerable progress on advancing toward a final design and the first phase of construction. The Community Stakeholder Committee has convened 3 times and submitted nearly a dozen recommendations that our architects and engineers are incorporating into the design for the 85-acre Public Safety Training Center Campus.

FACILITY UPDATES

Community Stakeholder Advisory Committee recommendations include:

- Relocation of Firing Range to most southern portion of the site (closest to industrial park)
- Reduction in the size of the Firing Range
- Baffling around the Firing Range to further mitigate impact to residents
- Engagement of an acoustic engineer to provide recommendations around other opportunities to further reduce facility noise
- Removal of Explosives from the site plan
- Addition of 100ft minimum tree buffer around the facility
- Addition of Constitution Rd. site entrance to alleviate vehicular traffic on Key Rd.
- Sidewalks along Key Rd. for pedestrian traffic
- Addition of designated public parking at the site
- Addition of security cameras, license plate readers and streetlights around the site and neighboring communities


