#### 1. About These Terms

- 1.2 Please read these Terms carefully before using the Site.
- 1.3 By using or accessing the Site, or by placing an order, you agree to be legally bound by these Terms.

#### 2. Definitions

- **Vendor**: A supplier of Goods listed on our Site.

- You / Your: The person accessing the Site or placing orders.

## 3. Using the Site & Placing Orders

- 3.1 The Site allows you to place orders with trusted Vendors. Yalla Halal acts as a **commercial agent** on behalf of Vendors to conclude your sale.
- 3.2 You must be at least 18 years old to place an order.
- 3.3 You are responsible for:
  - All costs incurred in accessing the Site;

  - Reviewing your order details carefully before purchase;
  - Keeping your account login details secure.
    - 3.4 Orders cannot be cancelled or changed unless the Vendor agrees.

### 4. Price & Payment

- 4.1 Prices shown on the Site include VAT but exclude delivery fees.
- 4.2 Delivery fees are confirmed at checkout.
- 4.3 A **5**% **service fee** is applied to all orders placed through the Site.
- 4.4 In the case of pricing errors, you will be informed before your order is processed and given the option to cancel or proceed at the correct price.
- 4.5 Payments are securely processed via **Stripe**.
- 4.6 All orders are placed with Yalla Halal acting as a commercial agent for the Vendor.

- 5.1 Delivery charges are calculated and displayed during checkout.
- 5.2 Vendors are responsible for preparing and fulfilling orders. Delivery timing and logistics may vary.
- 5.3 For collection orders, you will receive a notification when your order is ready.
