The Website Sub-Committee Report was read by Andrew B. Alison G spoke to the prototype website which has been constructed with the following attributes in mind:

- Simplicity and ease of navigation, no superfluous content.
- Avoid duplication of content available on the Australian GSO, General Service and relevant Local Service websites.
- Content specific to AA Australia general service structure and running of the Virtual Area.
- Contain pertinent information for Australian virtual groups and their GSRs to maximise opportunities to participate in the general service structure.

Based on cost, available features and projected Virtual Area requirements, the subcommittee recommended the Virtual Area go with:

GoDaddy Website Builder and Domain + Managed WordPress Basic (20GB storage):

- o \$11.95 monthly (\$143.40 annually)
- o Increasing to \$15.95 monthly (\$191.40 annually) in 2024
- o Custom domain for \$0.29 increasing to \$2.91monthly in March 2024
