## **2024-25 Pre-K Programs and Admission Requirement**

### **Pre-K Programs:**

- PreK-3 and Pre-K 4 Full Day are full day programs from Monday to Thursday 8:00 am -2:30 pm and Friday 8:00 am - 12:00 pm. Registration fee is nonrefundable and other tuition fees apply.
- Pre-K AM is from Monday to Friday 8:00am-11:00 am. The program is free with VPK voucher.
- Pre-K PM is from Monday to Thursday 11:45 am -3:30 pm. The program is free with VPK voucher.

### **To register at MAGO in 2024-25 school year, all students are required to have the following:**

- *A copy of birth certificate* for verification of legal name, age and guardianship. No other forms are accepted.
- *Florida Certification of Immunization (Form DH680)*. No other forms are accepted.
- *Proof of physical examination* (school entry health examination) must be done within a year of enrollment (first day of entry at school).
- *VPK voucher* (PreK-4 only)-**VPK voucher must be signed by the APPLICANT in person at MAGO Account Office**

### **Other Requirements:**

- Pre-K 3 students must be 3 years old and Pre-K 4 students must be 4 years old by September 1, 2024.
- Student must be completely toilet-trained and able to undress/dress him/herself without any assistance.
- Student must be able to communicate and understand English.
- MAGO reserves the right to dismiss students who do not meet the requirements. Parents must notify the school 30 in advance when withdrawing a student. Students are not allowed to attend school when health documents are expired.
- If the child is not living with both parents, the legal guardian must provide proof of guardianship.

### **Voluntary Pre-Kindergarten (VPK) Voucher**

- Voluntary Pre-Kindergarten (VPK) – applicant must be 4 years old by 9/1/2024. For more information visit [www.vpkhelp.org](http://www.vpkhelp.org). VPK Voucher must be signed by the APPLICANT in person at the Account Office.

### **Pick-Up/Drop Off Requirements**

- Emergency contacts and authorized pick-up individuals must bring government-issued identification when they pick up your child. All pick-up individuals must be over 18 years old and be on the authorized pick-up list. **Daily signing in and out are required.**
- If your child(ren) is not picked up after 11:05 am for VPK half day, 3:35 pm for VPK PM or after 2:35 pm for the full day program, a late pick-up fee of \$5.00/5 minutes will be added to your monthly invoice. Per state licensing regulations, we are required to contact the local authorities for any child(ren) not picked up after 4:00 pm if we do not hear from you or we are unable to reach you or your emergency contact listed.
- For all children's safety, it is critical to use your pick-up card to pick up your child. To ensure the safety of our school's staff and children, please keep your card secured with you.
