CALL TO ORDER OF OPEN SESSION:

Debbie 2nd the motion, and it passed unanimously. Debbie made the motion to approve the funds for the monthly service for the 6 new street lights. Bobby 2nd the motion, and it passed unanimously.

Website Review/Email Setup:

Bobby made the suggestion of upgrading the website provider's service to meet the communication needs of the Deer Trail property owners. The issue was discussed and the board decided to have Bobby research it more.

NEW BUSINESS:

Noise Policy: The board discussed the policy and decided to "table" it until later.

<u>Yard Sales:</u> Yard sales and several options for the Deer Trail community were discussed by the board. They decided to "table" it until a later date.
