MOVE-OUT All exhibit space displays must remain in place until the show closes on Thursday. Early departure is not permitted - penalties apply. Accommodations may be made upon request to pick up materials on Friday morning for those who can not move out after closing on Thursday.

COST & FURNISHINGS

The Los Angeles Fabric Show offers paneled exhibit spaces with adjustable rods for hanging of materials (either single or double hanging for each panel). Table (standard table is 6ft) and chairs are included. Rates are subject to change. Book now to confirm the following spaces.

Paneled Exhibit Space Options include: 20' x 6' = \$2200. 15' x 6' = \$1650, 10' x 6' = \$1100. At this time customized space configurations are also available including 8' and 10' deep exhibit spaces. Corners +\$250.

Table Space Options: Start at \$500 for a 4ft table with chairs.

Pop Up (Free-standing) Banners are permitted, and must be placed within your space and may not block the view of your neighbor (management reserves the right to reposition banners). Nothing may be attached to the partitions, columns, or walls. We will provide a diagram of space layouts - it is necessary to make sure exhibitors have pre-approved layouts for furnishings (including tables and exhibitor owned racks). Exhibitors may bring their own racks, or displays, with prior approval (industrial/high racks are not permitted). Additional tables may be available depending up space size & must also be ordered in advance.

SHIPPING IN AND OUT

Exhibitors may ship boxes, suitcases, etc to the show and leave packages for pick by carrier after the show. Details will be provided. Exhibitors are responsible for tracking their packages - in and out. Exhibitors may not remove any display materials before the show floor closes. Arrangements may be made for pick up on Friday morning if necessary.

TERMS & CONDITIONS Exhibitor agrees to make no claims against The Fabric Shows (aka Los Angeles Fabric Show), Huber Power Corp, or Power Enterprises LLC, its employees and/or agents, or the venue, agents or employees; for loss, theft, damage or destruction of goods; or for any injury to them or their employees, and/or agents while on the show site. Exhibit shall remain in place until the show closes. Exhibitor agrees to keep their property within the confines of your exhibit space at all times the show is open. The Show management reserves the right to make changes to the floor plan and exhibit spaces assigned. A non-refundable deposit is required to reserve space. Full payment is due 3 weeks prior to the show. Exhibit fees are non-refundable. The Exhibitor herein acknowledges receipt and agreement to all of the Terms and Conditions.
