## **Quality Focus Update**

The NYUPN Clinically Integrated Network has created postcards to send to patients for important, past-due health screenings. The project is part of a greater educational marketing campaign to promote the importance of certain screenings and tests, and help patients schedule appointments for those screenings and tests, as needed. These mailings will be made based on data distributed by health plans.

The postcard mailing schedule is as follows, and mailings will be repeated throughout the year, as needed:

March	colonoscopy	
April	annual wellness exam	
May	pediatric well visit	
July	diabetes health exam (ie. HbA1c, nephropathy screening and eye exam)	
August	pediatric well visit	
October	mammograms	

The Access Center will be making outreach phone calls to patients, on behalf of the practices, to remind and help patients schedule appropriate appointments.

#### **NYULMC Addresses Zika Virus**

NYU Langone is providing several sources of information pertaining to the Zika virus (flavivirus), which according to the Centers for Disease Control (http://www.cdc.gov/zika/about/index.html), can "spread to people primarily through the bite of an infected Aedes species mosquito."

The Zika virus, first identified in 1947 in Uganda's Zika Forest, is related to dengue, yellow fever and West Nile virus. There have been sporadic outbreaks of the virus throughout Africa, the Pacific Islands and Southeast Asia. Currently, there is an outbreak affecting Central and South America and the Caribbean; the virus has been linked to an increase in neonatal microcephaly in Brazil.

New York State is offering Zika virus testing for:

- all pregnant women who traveled while pregnant to countries with Zika virus transmission, whether they had symptoms or not;
- neonates with microcephaly or intracranial calcifications born to women who traveled to areas with Zika virus transmission while pregnant;
- all persons who traveled to areas with Zika virus transmission who present with Guillain-Barre syndrome;
- all persons who traveled to areas with Zika virus transmission who developed symptoms consistent with Zika virus infection within four weeks of travel.

NYU Langone's Department of Infection Prevention and Control, Division of Maternal Fetal Medicine and Department of Pediatrics are collaborating to create a Website, posters and guidelines for medical center providers, and are working with internal and external communications to create awareness about the virus.

## **MCIT Issues Security Warning About Ransomware**

MCIT is raising awareness about "Locky" ransomware, a computer virus that can spread through organizations via aggressive spam attacks and infect legitimate Websites. One version of the attack includes a fake email invoice containing infected Word documents, but hackers have circulated many variants.

The "Locky" ransomware has spread through several medical centers, including Hollywood Presbyterian Medical Center, which had its computer systems disabled, ultimately forcing the diversion of some patients to other hospitals.

MCIT has issued guidelines for how to prevent the "Locky" ransomware from infecting NYU Langone Medical Center:

- Do not click on links or open attachments from untrusted sources;
- Be mindful of websites; malware can be downloaded automatically on to a computer from an infected Website;
- Store data on MCIT Network drives, where it will be securely backed up. Once a device has been infected, data from it may not be recovered;
- If an NYU Langone device might have been infected by ransomware, do not use it and report the concern to the Help Desk.

### **Managed Care Update**

### Payors Update Authorization Requirements

Effective this month, Fidelis will require prior authorization for the following gastrointestinal procedures when performed in an outpatient setting.

FIDELIS Procedures & Services	CPT Codes
Upper GI endoscopy biopsy	43239
Colonoscopy and biopsy	45380
Diagnostic colonoscopy	45378
Lesion removal colonoscopy	45385
Lesion removal colonoscopy	45384

Fidelis does not require a prior authorization when these procedures are performed in an office.

United Healthcare has updated the authorization requirements for certain procedures in an outpatient hospital setting for certain commercial plans. Effective May 2, 2016, the changes will affect some gynecological procedures, and tonsillectomy and adenoidectomy codes. If performed in an office setting, United Healthcare will not require authorization.

# Practice Profile: NYU Langone Internal Medicine—Hudson Valley

NYU Langone Internal Medicine— Hudson Valley has opened a new location in Cortlandt Manor. The Crompond Road space includes 10 new exam rooms and an openconcept patient reception and waiting area, as well as accessible parking.

The practice isn't just physically accessible to patients, says Westchester/Hudson Valley Regional Manager Katelyn Milavsky. "We have short wait times and it's easy to get a same-day appointment at our practice," she explains.

The five physicians work at three locations, and are able to accommodate patients who vary in age, background and medical profile. The physicians treat patients with chronic diseases, including diabetes, hypertension, asthma, chronic obstructive pulmonary disease, obesity, anxiety, and depression.
