## ETIQUETTE TIPS: BETTER GOLF FOR ALL TGPC MEMBERS

1. Play without delay and keep up with the group in front of you, not in front of the group behind you. Don't be the slowest player.
2. Don't move, talk or stand close to a player making a stroke, don't stand on the line of play, either behind the hole or directly behind the ball. Know where to stand and when to be quiet. On the putting green don't drop your clubs or the flagstick, or lean on your putter.
3. Don't play until the group in front of you is out of the way. Shout a warning, "fore" if your ball may hit someone.
- 4 Repair divot holes and ball-marks and rake footprints in the bunker after your shot.
5. In case of a serious breach of a rule, the Committee has the authority to disqualify a player. Help your fellow members if they do not know a rule.
6. Drive carefully not to damage the course. Do not drive close to the green or park in front of it.
7. Adhere to the dress code of the golf course. Be respectful of the course rules and golf course staff.
8. Keep your temper under control; throwing clubs, sulking and barking profanity makes everyone uneasy. Turn off you cell phone
9. Lend a hand when you can; help look for lost balls. Better yet -- watch for errant golf balls so they do not become lost balls.
10. Any TGPC member who exhibits inappropriate behavior at a golf course will be individually responsible for the consequences.
