

Terms of Service

Welcome to Ready Set Mow. These Terms of Service (“Terms”) govern your access to and use of the Ready Set Mow mobile application, website (readysetmowsc.com), and related services (collectively, the “Platform”).

1. Description of Services

Ready Set Mow provides a digital platform that connects customers with independent technicians for lawn care and outdoor property services.

Ready Set Mow facilitates scheduling, communication, and service documentation but does not directly perform landscaping services unless otherwise stated.

2. User Accounts

To use certain features of the Platform, you must create an account.

3. Technician Relationship

Technicians using the Platform are independent contractors.

They are not employees, agents, partners, or representatives of Ready Set Mow.

Ready Set Mow does not control the manner, timing, or method of services performed by technicians. Customers acknowledge that service agreements are between the customer and the assigned technician.

4. Service Requests

When a customer submits a service request:

- The request is made available to qualified technicians
- A technician may accept the job
- Service completion is documented within the Platform

Ready Set Mow does not guarantee technician availability or specific outcomes.

5. SMS & Text Message Communications

By providing your phone number and creating an account, you consent to receive SMS text messages from Ready Set Mow related to your use of the Platform.

These messages may include:

- Appointment confirmations
- Service reminders
- Job status updates
- Technician arrival notifications
- Customer support communications

Message Frequency

Message frequency varies depending on your service activity.

Message & Data Rates

Message and data rates may apply based on your mobile carrier plan.

Opt-Out

You may opt out at any time by replying:

After sending STOP, you will receive confirmation and will no longer receive SMS messages unless you re-subscribe.
