1. Information We Collect

Personal Information

When you create an account or use our services, we may collect:

Technician Information

If you register as a technician, we may collect:

- Name

- Service completion details

Automatically Collected Information



We may collect limited technical data including:

- Device type
- Operating system
- IP address
- App usage data
- Error logs

This data helps us improve platform performance and reliability.

2. Push Notifications

With your permission, we may send push notifications regarding:

- Service confirmations
- Appointment reminders
- Job status updates
- Technician activity
- Account alerts

To deliver push notifications, we may collect and store a device token provided by your mobile operating system. Device tokens are used solely for notification delivery and are not used to personally identify you.

You may disable push notifications at any time through your device settings.

3. How We Use Your Information

We use your information to:

- Create and manage user accounts
- Process service requests
- Connect customers with technicians
- Store and display uploaded photos
- Provide customer support



- Improve platform functionality
 - Maintain platform security
 - Comply with legal obligations

4. User Content & Photos

Users may upload images and property information for service documentation.

By submitting content, you grant Ready Set Mow a limited, non-exclusive license to store, process, and display such content solely for operating the Platform.

We do not sell user-uploaded content.

5. Sharing of Information

We do not sell personal information.

We may share information:

- Between customers and assigned technicians
 - With third-party service providers necessary to operate the Platform
 - When required by law
 - To protect legal rights or prevent fraud
