Re: Ethics Violation

Dear Madam City Clerk,

I am writing on behalf of DBlastMedia, our subscribers, and partners to lodge a formal complaint against Police Chief Devan A. Martin for violations of the City of Seat Pleasant Public Ethics Ordinance. We allege Chief Martin gave rise to circumstances suggesting that favoritism is a motivating force in the conduct of the City's business, influenced the City to retain the business services of a specific person, and used the prestige of office to inappropriately benefit others.

This complaint is based on multiple occurrences between August 2017 and August 2019. The first happened in August 2017, when Chief Martin engaged in contract negotiations for Kevin Durant Day security resources, with Guardian Security Services, LLC, a company owned by his friend and subordinate employee, Wayne Harris. The negotiations were ultimately abandoned when the festivities were cancelled. On November 7, 2017, Chief Martin forwarded an email about home buying from his friend Terrell Bates to Economic Development Director Weyimi Ayu, along with the message, "Mr. Ayu, Mr. Bates is a former police officer for our city, who left to pursue other opportunities. Any help you offer him would be appreciated greatly." Bates had involuntarily resigned from his job just three days earlier.

On December 11, 2017, Chief Martin influenced the decision to hire J Cheri Riley, whom he was closely acquainted with, as the Administrative Assistant for Economic Development. On May 22, 2018, he forwarded another close female acquaintance's (T.R.) resume to Director Sharron Lipford, along with the remark, "please find attached a resume for an highly recommended applicant for your open position."


On September 25, 2018, Chief Martin arranged for Terrell Bates to receive an equipment hauling contract with the City worth over \$10,000. On December 17, 2018, Chief Martin forwarded the resume of his girlfriend's friend (Y.M.) directly to Anthony Coleman, the Mayor's Executive Assistant. On January 28, 2019, Chief Martin enlisted Guardian Security Services, LLC, to provide security services for the State of the City Address at Central High School. Wayne Harris still worked for the City at the time. On March 8, 2019, Chief Martin leveraged his relationship with the Prince George's County Police to seek favor for a close female acquaintance (V.A.) who had applied for a job with the county police.

Then, on May 22, 2019, he sent his friend's resume (J.S.) to Human Resources Director Anthony Biddix, and Executive Assistant Anthony Coleman, along with the message, "please see the attached for any open positions in the near future." Finally, on August 12, 2019, Chief Martin forwarded yet another close female acquaintance's (J.H.) resume to Executive Assistant Anthony Coleman.

The accompanying documents and other information provided to DBlastMedia shows that Chief Martin has routinely abused his position to advance self-interest and those of his acquaintances and friends. It is our intention to have the situation investigated by the Ethics Commission and, if criminality is involved, the Maryland State Prosecutor.


