#### **DPI Update**

Happy Spring! Winter has not given up its grip on the weather in some parts of the state yet, but we know spring showers and summer flowers are on their way. And this means School Year 2024 is about to wrap up.

Remember to get all those records together that need to be stored safely away for the next three years including production records for each meal served and supporting documentation like Child Nutrition labels and Product Formulations Statements. Each month's claim for reimbursement, along with its supporting documents like edit checks and free/reduced applications, also needs to be stored for those same three years before shredding. The completed professional development logs for each staff member showing civil rights training should also be in the storage box.

Finally, add a copy of the back-to-school letter/packet that is sent to households at the beginning of the school year. This proves that the free/reduced applications were sent out, that the household was updated on the progress of student wellness goals through the local wellness policy, and that they were made aware of the school's unpaid meal charge procedures.

#### Coming in 2025

USDA -Food and Nutrition Service has released several memos recently:

**New Food Yields in the Food Buying Guide:** USDA has finished food yield research on canned mixed fruit, canned beef, instant long grain, and quick medium grain brown rice AND cactus fruit (prickly pear). Check it out at: https://foodbuyingguide.fns.usda.gov/

**The Child Nutrition Database, Release 27:** This database is important for any menu planner who is using nutrition software. Find information on the update at: https://www.fns.usda.gov/tn/child-nutrition-database

Paid Lunch Equity: Guidance for School Year 2024-2025 in SP 14-2024: Schools with a zero or positive balance in the school food service account on June 30, 2024, do not need to raise student meal prices for the next school year based on the Paid Lunch Equity Tool. Conversely, if the school food service account ends in the negative, meal prices are expected to be raised.

Summer Food Service Program guidance on Non-Congregate Meal Service in Rural Areas: If any North Dakota school district is interested in providing Summer Food Service to its rural areas or in another eligible site, please contact NDDPI SFSP manager Melissa Anderson at mlanderson@nd.gov. Sign-up is open now!

At this printing, we have not heard about the new rules for the regular School Breakfast or National School Lunch program meal pattern. We do know that there will be no changes for the upcoming school year. The annual Back to School Workshops will cover changes for the following school year, 2025-2026. These have been scheduled and registration is open! Dates are either July 30th or July 31st in Fargo, August 6th or 7th in Bismarck, or August 8th in Minot. ## Legislative Update - Spring 2024




Lynelle Johnson, Cindy Hogenson, Gina Giovannoni, and I attended the 2024 Legislative Action Conference in Washington, DC. There was valuable input given from attendees to the USDA representatives regarding the proposed rule changes. While we were in DC we met with staffers from Senator Hoeven and Senator Cramer office. We were able to meet with Representative Armstrong in person. During these meetings, we focused on the SNA position paper which included maintaining current nutrition standards, permanently increasing federal reimbursement rates, and expanding NSLP/SBP to offer school meals for all students at no charge. Our legislators were most interested in learning more about potential challenges program operators would face if the proposed nutrition standards were put in place.

As of right now, USDA has not released the final ruling on the proposed nutrition standards. Some of these proposed changes include a reduction in sugar, flavored milk, more whole grains, and reduced sodium levels. USDA is proposing a gradual implementation of these nutrition standards between

2024-2029.






## Bottineau, Central Cass, & Bowbells Celebrate National School Breakfast Week


