	Robin – normally what we do is send whatever is left over prudent reserved, after bills are paid which I thought we were under, but it looks like we were brought back up. Motion to accept and seconded.
Policy and Procedure:	Aisha – the Policy and Procedure committee met on July 7th at the St. Ann's Church in Washingtonville. It was myself and the secretary, Robin. We read traditions and concepts. There was discussion concerning H&I subcommittee specifically, the need for submission of accounting for expenses and monies spent for the recent learning day. This is not only for H&I, it is for any standing committee that has a budget; must submit a written, detailed, accounting of expenses.
	We also discussed the decision of the Learning Day. The H&I subcommittee has changed it to once a year to spend the \$300 allotted for the learning day expenses. This does not agree with the current H&I policy and the subcommittee will need to make a motion to have it changed. The subcommittee also needs to submit an expense report of the literature along with the inventory they have on hand and the amount that is being distributed.

Robin - okay so we need to form a new adhoc committee to move forward with this

Billy – there is something we need to address. There are other areas involved in this right now so we're going to have a point of responsibility at each area but the committee will be separate. It won't be the Open Arms Area because we're forming our own region but we can nominate someone from each area. I will volunteer to be that point, I'm not going to be the chair, we'll have a temp chair until we can make a flyer so anyone interested in getting involved has the opportunity to show up. We need to have a full committee with all positions filled in order to move forward. Each month we'll bring back whatever information we find to each area.

Robin-how will we title that?

Billy - I don't know I've never done this before. Does anyone have an idea? We're no longer an open arms area committee.

Marty – it is no longer and adhoc committee, we're not just representing the open arms area.

Derek- maybe this is out of line but in light of so many abstentions and being part of the area for a while, my gut feeling is that I don't think the groups have had the opportunity to really understand, or at least the groups I've been to. Making a new region is a rather large proposition and I know you know that and maybe I'm out of terms but I don't believe that the body of our whole area really understands.

Billy – the adhoc committee was created to gather information and I was he chair. We gathered more information then needed and got other people involved. We brought back all that information and everything was put into the minutes so you had as much information as any other group. The motion passed. It was in the minutes and on the website and it was very important information. We sent it out as what we had and to see how everyone agreed with it. To say it's out of order is incorrect. Everyone is entitled to an opinion.

Mike – I'm speaking for my group and we read everything that was there. The motion passed and I can't argue that, it hit the floor and did all that good stuff. The problem I have is with the procedure of what was done before this. There wasno pros or cons and no discussion about a lot of other things that are going on. It basically feels like we're jumping the gun. We've basically given the go ahead to start a new region and we haven't even explored a lot of other things. Regions normally take up to a year to start. The problem is that we kind of voted on something blindly because now there's discussion that there are other people from other areas that are involved, I would have loved to have known that you guys were going to do a committee like that together so that all the areas have a say.

Billy – you nominated me as the chair for a committee to go out and do research. That research was to go out and see if anyone else was going to get involved. We took it and went to other areas and all showed some level of interest. They have sent 2 members of their areas to represent their areas but we haven't even had a meeting yet. There is a lot of work to be done and a lot of questions to be answered. We don't know the outcome we just got permission to proceed. We could sit here and put this under a microscope and sit here for another 10 years doing the same thing over and over again or we can proceed and see what the other areas have to put in.

Mike – just to follow up, the problem is that the question I have and the reason we voted no is because of the very reason that we didn't know all of that, we didn't know that you were going to continue to find more information before moving forward. The motion is pretty cut and dry that we are starting a new region. It doesn't say that there is going to be further research with other areas, we were very confused as a home group. We voted unanimously no because there wasn't a lot of information.

Lauren – these minutes came out 3 days after the area meeting and I wrote word for word everything that Marty and Billy said and the second line says they spoke to Rockland and the Lower Hudson Valley Area and both were interested. There are also 7 other pages of information that they came up with. If anyone says that there wasn't enough information, I'm not sure that this was read. Mike – they did a lot of research, I'm not denying that you guys did an excellent job. The problem is that there was certain information that wasn't answered, like they said they were going to do a non-profit, they didn't know how to label, it as a corporation or not. I read it word for word. There are little details that weren't answered.

Marty – this was a temporary thing. It was a temporary adhoc committee that was formed to gather information. The committee for the region is something else in itself that needs BOD members. At some point and time this area is going to have to decide if they want to be a part of that.

Billy – we're still going to come back and bring information to the area. We do know that it takes time and effort and we asked for permission and for the groups to support us because there is no point moving forward without support from the groups.

Mark R – I thought that the motion was to continue to give the committee the power to continue getting information. Maybe I didn't read it either.

Billy – I made a statement that we'll need to do fundraisers to make the money to create the corporation. There was discussion on how we could make the monies to move forward. Without a BOD and a corporation we can't move forward. At any point and time the area can say they don't want to be a part of, even a group can say that they don't want to join. We're not forcing anyone to do this. There are no strong arm tactics, this is your choice.

Marty – Mark, the reason for that was to figure out if we should set out on that course or not, to find out all the information.

Mark – I thought it was just to find out if the groups are interested.

Billy – that's what it was

Steve – you guys are doing a great job and I look forward to next month to hear what you have to report. The problem was last month, and no offense Robin, 90% of the conversation was between you and them and people from the floor had our hands up and weren't acknowledged and there were no pros and cons. There were also questions that were never answered. Now let's let these guys do their jobs and find out some more information.

Billy – now I don't know if this needs to go to a vote for me to be a point of information to bring back our findings, I don't know because I've never been in this position before, I don't mind doing it as a member of the committee that's going to be doing this work. I can just make a report and bring that to area.

Marty – the last time I was involved in something like this I don't remember there being a title. I heard Aisha's definition of an adhoc committee, basically the second part of what were doing is going to come to an end. It's not just Open Arms Area either, there are other areas involved.

Robin – I think we need to think about a name, how about RC development coordinator for the Open Arms Area? Billy – listen I'm just saying that I volunteer to bring that information back to the area so that the groups can get it. That's what we want, for the groups to know what's going on and make decisions and have ideas to bring back here and hopefully some of members will come to our meeting and get involved. Sometimes we lose a lot in our failure to communicate well in our rush to get out of here and some information can be left out that should be included. Whether we agree or not, it's important to disagree.

Marty – she does have a point, what we hope for is that in 9 months or a year when it's all done that we have all 21 votes to say yes

Robin – what I'm going to suggest is to table it for a month to come back with a job description and title, we're not in a big hurry and it's not time sensitive.

Billy – we're planning to have our first meeting in September. We haven't set a time and place yet. We were waiting for tonight to have permission.
