**RELEASE AND WAIVER FORM FOR A MINOR**  
**(for participants under the age of 18)**

I, \_\_\_\_\_ am the parent or legal guardian of \_\_\_\_\_ (“my child”), a participant in the Alley Pond Adventure Course (“Adventure Course”). Both my child and I agree that when he or she is participating in the Adventure Course, that he or she will cooperate promptly and fully with all directions of the Adventure Course personnel and wear all required safety equipment provided by the staff, including, but not limited to, helmets, harnesses, and belay systems. We also agree that he or she will follow all of the rules and regulations of the New York City Department of Parks and Recreation (“Parks”), and all applicable City of New York (“City”), New York State, and Federal laws, rules and regulations. We understand that her or his failure to behave appropriately may result in removal from the Adventure Course.

I understand the nature of the activities that my child will be involved in, including, but not limited to, running, jumping, leaping, low ropes elements (on the ground or on cables suspended 18 inches off the ground), and high ropes elements (cables suspended 45 feet in the air). I represent that my child is physically fit and that he or she does not have a medical condition that would restrict him or her from participating in this type of physical activity.

I understand and acknowledge that there are inherent risks with my child’s participation in the Adventure Course, including the risks of serious bodily injury and death, and I hereby assume all dangers and risks associated therewith. I acknowledge that the instruction and supervision provided by the Adventure Course staff may not prevent injury and does not guarantee that injury will not occur. My child and I understand that he or she is responsible for his or her own behavior and agree that he or she will only perform tasks that he or she feels comfortable and safe doing.

I understand that the City will not cover any medical expenses due to injury received through my child’s participation in the Adventure Course. In partial consideration of my child’s acceptance as a participant in the Adventure Course, we hereby agree to waive all claims we have or may have against the City and Parks, in relation to the Adventure Course, and agree to release and hold harmless the City and Parks, along with their respective employees, agents, affiliates, sponsors, or other representatives, from any and all claims for any and all expenses, personal injury, loss, or damages incurred during or in connection with my child’s participation in the Adventure Course.
