- use of two hands (except jurior and L1 horses shown in a smalle bit) hackamore), more than one finger between split reins or any lingers between romal reins (except in the two rein)
- fallure to open and shut gate, or failure to complete gate

Disqualified - 0 Score

- lameness
- distrespect or misconduct
- feozi equipment
- willful abuse
- leaving working area before pattern is complete
- improper western attire - fall of horse/rider
