

Terms of Services - Domates

Effective Date: April 1st, 2026

The following terms and conditions, which include and hereby incorporate the Privacy Policy at <https://kingdom-games.com/privacy-policy>(collectively, "Terms of Service") are a binding legal agreement between you and DOMATES OYUN YAZILIM LIMITED SIRKETI., its subsidiaries and affiliated companies (hereinafter "Domates" or "Us" or "We") regarding your use of Domates's, websites and related services (the "Service").

Previous to using the Service, including browsing any Domates website or accessing any Domates games, you must agree to these Terms of Service and the Privacy Policy.

Registering an account on the Service (an "Account") may be required from you. By registering for an Account or otherwise using the Service, you confirm that (1) you are age 13 or older, (2) you understand and agree to these Terms of Use, and (3) if you are between the ages of 13 and 18, your legal guardian has reviewed and agrees to these Terms of Use.

If you access the Service from a Social Networking Site ("SNS"), such as Facebook or Google+, you shall comply with its terms of service/use as well as these Terms of Service.

YOU ARE AGREEING TO THE TERMS OF SERVICE BY INSTALLING, USING OR OTHERWISE ACCESSING THE SERVICE. IF YOU DO NOT AGREE TO THESE TERMS OF SERVICE, PLEASE DO NOT INSTALL, USE OR OTHERWISE ACCESS THE SERVICE. USE OF THE SERVICE IS VOID WHERE PROHIBITED.

Portions of these Terms of Service and its Privacy Policy may be changed, modified, added or removed at any time at Domates's discretion, by posting the amended terms on the Service. Your acceptance of any changes will be indicated by your continued use of the Service. If at any point you do not agree to any portion of the then-current version of our Terms of Service, the Domates Privacy Policy, or any other Domates policy, rules or codes of conduct related to your use of the Service, you shall immediately stop using the Service, as your license to use the Service will be terminated by you not accepting the Terms of Service.

1. License

1.1. Grant of a Limited License to Use the Service

Subject to your agreement and continuing compliance with these Terms of Service and any other relevant Domates policies, Domates grants you a non-exclusive, non-transferable, non-sub-licensable, revocable limited license to access and use the Service for your own non-commercial entertainment purposes. Such license is subject to the limitations below and you agree not to use the Service for any other purpose.

The following restrictions apply to the use of the Service:

In addition to not creating an Account or accessing the Service if you are under the age of 13, you shall deny access to children under the age of 13 and restrict use by minors. You accept full responsibility for any unauthorized use of the Service by minors, related to your Account. You are also responsible for any use of your credit card or other payment instrument (e.g. PayPal) by minors.

If you have been previously banned from using the Service, you shall not try to use the Service in another way. You shall not create an Account using false information or under a false identity. You shall not sell, rent or give away your Account to other entities.

Login Information and Your Account

You are responsible for anything that happens through your Account and all uses of the Login Information, including purchases, whether or not authorized by you.

Domates reserves the right to remove or reclaim any usernames at any time and for any reason, including but not limited to claims by a third party that a username violates the third party's rights.

The Service supports only one Account per game on a supported device.

License Limitations

Any use of the Service in violation of these License Limitations is strictly prohibited, can result in the immediate revocation of your limited license and may subject you to liability for violations of law.

You agree that you will not, under any circumstances:

Engage in any act that Domates deems to be in conflict with the spirit or intent of the Service or make improper use of Domates's support services.

Use cheats, exploits, automation software, bots, hacks, mods or any unauthorized third-party software designed to modify or interfere with the Service, any Domates Game or any Domates game experience or without Domates's express written consent, modify or cause to be modified any files that are a part of the Service or any Domates game.

Disrupt, overburden, or aid or assist in the disruption or overburdening of any computer or server ("Server") used to offer or support the Service or any Domates game environment.

Institute, assist, or become involved in any type of attack, including without limitation distribution of a virus, denial of service attacks upon the Service, or other attempts to disrupt the Service or any other person's use or enjoyment of the Service.

Attempt to gain unauthorized access to the Service, Accounts registered to others or to the computers, Servers, or networks connected to the Service by any means other than the user interface provided by Domates, including but not limited to, by circumventing or modifying, attempting to circumvent or modify, or encouraging or assisting any other person to circumvent or modify, any security, technology, device, or software that is part of the Service.

Post any information that is abusive, threatening, obscene, defamatory, libelous, contains nudity or excessive violence; is racially, sexually, religiously, or otherwise objectionable or offensive, or that contains a link to such content.

Attempt to, or harass, abuse, or harm, or advocate or incite harassment, abuse, or harm of another person, group, including Domates employees, including Domates's customer service representatives.

Make available through the Service any material or information that infringes any copyright, trademark, patent, trade secret, right of privacy, right of publicity, or other right of any person or entity or impersonates any other person, including without limitation a Domates employee.

Reverse engineer, decompile, disassemble, decipher or otherwise attempt to derive the source code for any underlying software or other intellectual property used to provide the Service or any Domates game, or to obtain any information from the Service or any Domates game using any method not expressly permitted by Domates.

Solicit or attempt to solicit personal information from other users of the Service or any Domates game or collect or post anyone's private information, including personally identifiable information (whether in text, image or video form), identification documents, or financial information through the Service.

Domates reserves the right to determine what conduct it considers to be in violation of the rules of use or otherwise outside the intent or spirit of these Terms of Service or the Service itself. Domates reserves the right to take action as a result, which may include terminating your Account and prohibiting you from using the Service in whole or in part.

1.2. Suspension and Termination of Account and Service

Without limiting any other remedies, Domates reserves the right to limit, modify, suspend, terminate or delete any Account or access to the Service, in whole or in part, in case of failure (or reasonable suspicion of such a case) to comply with any part of these Terms of Service, or for actual or suspected illegal or improper use of the Service, with or without notice to you. As a result of account limitation or termination, you may lose your user name and persona, as well as any benefits, privileges earned items and purchased items associated with your use of the Service, and Domates will be under no obligation to compensate you for any such loss or result.

Without limiting any other remedies, Domates reserves the right to limit, modify, suspend, terminate or delete any Account or access to the Service, in whole or in part, as well as delay or remove hosted content and take any steps necessary to prevent your access to the Service in case of belief in the creation of risk or possible legal liabilities, infringement of intellectual property rights of third parties, or action inconsistent with the letter or spirit of our terms and policies.

Domates RESERVES THE RIGHT TO TERMINATE ANY ACCOUNT THAT HAS BEEN INACTIVE FOR 180 DAYS.

In the event of terminating your license to use the Service in whole or in part, as Domates reserves the right to stop offering and/or supporting the Service or a part of it at any time, Domates shall not be required to provide refunds, benefits or other compensation to users in connection with such discontinued Services. 2. Ownership

2.1. Games and Service

All rights, title and interest in and to the Service (including without limitation any games, titles, computer code, themes, objects, characters, character names, stories, dialogue, catch phrases, concepts, artwork, animations, sounds, musical compositions, audio-visual effects, methods of operation, moral rights, documentation, in-game chat transcripts, character profile information, recordings of games played using a Domates game client, and Domates game clients and server software) are owned by Domates.

Domates reserves all rights, including without limitation, all intellectual property rights or other proprietary rights, in connection with its games and the Service.

2.2. Accounts

Notwithstanding anything to the contrary herein, you acknowledge and agree that all rights related to the Account are and shall forever be owned by and inure to the benefit of Domates.

2.3. Virtual Items

Domates owns, has licensed, or otherwise has rights to use all of the content that appears in the Service or in Domates games. Notwithstanding any provision to the contrary herein, you agree that you have no right or title in or to any content that appears in the Service, including without limitation the virtual goods or currency appearing or originating in any Domates game, whether earned in a game or purchased from Domates, or any other attributes associated with an Account or stored on the Service.

2.4. User Content

The definition of "User Content" includes any communications, images, sounds, material, data, and information that you or other users upload or transmit through the Service, including without limitation any chat text.

By transmitting or submitting any User Content while using the Service, you affirm and warrant that such transmission or submission is (a) accurate and not confidential; (b) not in violation of any laws, contractual restrictions or other third party rights, and that you have permission from any third party whose personal information or intellectual property is comprised in the User Content; (c) free of viruses, adware, spyware, worms or other malicious code; and (d) you acknowledge and agree that any of your personal information within such content will at all times be processed by Domates in accordance with its Privacy Policy.

3.1. Content Screening

Domates assumes no responsibility for the conduct of any user submitting any User Content and assumes no responsibility for monitoring the Service for inappropriate content or conduct.

You acknowledge that you are using the Service is at your own risk and that by doing so you may be exposed to User Content that is offensive, indecent or otherwise not in line with your expectations.

Your interaction with the Service or communications (including without limitation chat text) related to using the Service may be monitored and/or recorded at our discretion by our representatives or technology. You further hereby grant to Domates the unconditional, irrevocable right to use any material or information included in User Content or in connection with it, including your name and likeness, without any obligation to you.

Domates does not claim any ownership rights to your User Content, and none of the provisions of these Terms of Service have the intention of restricting any rights that you may have to use and exploit your User Content. Domates also has no obligation to monitor or enforce your intellectual property rights in or to your User Content.

Except as prohibited by law, you waive any rights of attribution and/or any moral rights you may have in your User Content, regardless of any possible modifications to your User Content.

3.4. User Interactions

Your interactions related to the use of the Service (including any interactions with other users of the Service) are your sole responsibility. Domates assumes no obligation, but reserves the right, to become involved in those interactions in any way necessary.

In case of any suspected fraudulent, unlawful or improper activity, you will offer your full cooperation with Domates, including, but not limited to, granting access to any password-protected portions of your Account.

4.1. Purchases

ALL PURCHASES AND REDEMPTIONS OF THIRD-PARTY VIRTUAL CURRENCY MADE THROUGH THE SERVICE ARE FINAL AND NON-REFUNDABLE.

Your limited license to Virtual Items for use in Domates games is a service provided by Domates that commences immediately upon acceptance of your purchase by Domates.

4.2. Payment of Fees

You agree to pay all fees, applicable taxes and any costs incurred by you or anyone using an Account registered to you. Domates reserves the right to revise and change the pricing for the goods and services offered through the Service at any time.

YOU ACKNOWLEDGE THAT Domates IS NOT REQUIRED TO PROVIDE A REFUND FOR ANY REASON, AND THAT YOU WILL NOT RECEIVE MONEY OR OTHER COMPENSATION FOR UNUSED VIRTUAL ITEMS WHEN AN ACCOUNT IS CLOSED, WHETHER SUCH CLOSURE WAS VOLUNTARY OR INVOLUNTARY.

5. Updates to the Service

You acknowledge and agree that the Service is an evolving one and as such, Domates may update the Service, with or without notifying you, as well as require that you accept updates to the Service and to Domates's games you have installed on your device. You may need to update third party software from time to time in order to continue using the Service.

6. Disclaimer of Warranties

7. Limitation of Liability; Sole and Exclusive Remedy; Indemnification

Domates shall not be liable to you for any indirect, incidental, consequential, special, punitive or other similar damages, including but not limited to loss of revenues, lost profits, lost data or business interruption or other intangible losses (however such losses are qualified), arising out of or relating in any way to these Terms of Service or the Service itself, whether based on contract, tort or any other legal theory, and whether or not Domates has been advised of the possibility of such damages.

Domates's maximum liability shall be the amount you have paid to Domates in accordance with these Terms of Service in the six (6) months immediately preceding the date on which you first assert a claim. You acknowledge and agree that if you have not paid anything to Domates during such a time period, your sole remedy (and Domates's exclusive liability) for any dispute with Domates is to stop using the Service and to cancel your account.

As some jurisdictions do not allow the exclusion of certain warranties or the limitation or exclusion of liability for certain types of damages, some of the above disclaimers and limitations may not apply to you. To the extent that Domates may not, as a matter of applicable law, disclaim any warranty or limit its liability as set forth herein, the scope of such warranty and the extent of Domates's liability shall be the minimum permitted under such applicable law. In particular, nothing in these Terms of Service shall affect the statutory rights of any consumer or exclude or restrict any liability for death or personal injury arising from any negligence or fraud of Domates.

You agree to indemnify, defend and hold Domates harmless from any claim, demand, damages or other losses, including reasonable attorneys' fees, asserted by any third-party resulting from or arising out of your use of the Service, or any breach by you of these Terms of Service, however the foregoing does not apply if the infringement of rights is not attributable to your intentional or negligent behavior.

8. Dispute Resolution and Law

Should a dispute arise between you and Domates, it is strongly encouraged to first contact us directly in order to try and find resolution by going to our customer support site at <https://kingdomgames.helpshift.com/>.

You agree that all disputes between you and Domates shall be governed by the laws of British Virgin Islands, without regard to conflict of law provisions. You agree that any claim or dispute you may have against Domates must be resolved exclusively by a court located in England.

9. Severability

You and Domates agree that if any portion of these Terms of Service or of the Domates Privacy Policy is found illegal or unenforceable, in whole or in part by any court of competent jurisdiction, such provision shall, as to such jurisdiction, be ineffective solely to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of the terms, which shall continue to be in full force and effect.

10. General Provisions

10.1. Assignment

Domates reserves the right assign or delegate these Terms of Service and/or the Domates Privacy Policy, in whole or in part, to any person or entity at any time with or without your consent. You may not assign or delegate any rights or obligations under the Terms of Service or Privacy Policy without Domates's prior written consent.

10.2. Supplemental Policies

Domates may publish additional policies related to specific services such as forums, contests or loyalty programs. Your right to use such services is subject to those specific policies and these Terms of Service.

10.3. Entire Agreement

These Terms of Service, any Supplemental Policies and any documents expressly incorporated by reference herein (including the Domates Privacy Policy), contain the entire understanding of you and Domates, and supersede all prior understandings of the parties hereto relating to the

subject matter hereof, whether electronic, oral or written, or whether established by custom, practice, policy or precedent, between you and us with respect to the Service.

10.4. No Waiver

The failure of Domates to require or enforce strict compliance by you with any provision of these Terms of Service or the Domates Privacy Policy or failure to exercise any right under them shall not be construed as a waiver or relinquishment of Domates's right to assert or rely upon any such provision or right in that or any other instance.

The express waiver by Domates of any provision, condition, or requirement of these Terms of Service or the Domates Privacy Policy shall not constitute a waiver of any future obligation to comply with such provision, condition or requirement.

Except as expressly and specifically set forth in these Terms of Service, no representations, statements, consents, waivers, or other acts or omissions by Domates shall be deemed a modification of these Terms of Service nor legally binding, unless documented in physical writing, hand signed by you and a duly appointed officer of Domates.

10.5. Notices

We may notify you via postings on <https://kingdom-games.com>, and via e-mail or any other means of communication for which you provide information to us. All notices given by you or required from you under these Terms of Service or the Domates Privacy Policy shall be in writing and addressed to:

10.6. Equitable Remedies

You acknowledge that the rights granted and obligations made under these Terms of Service to Domates are of a unique and irreplaceable nature, the loss of which shall irreparably harm Domates and which cannot be replaced by monetary damages alone so that Domates shall be entitled to injunctive or other equitable relief (without the obligations of posting any bond or surety or proof of damages) in the event of any breach or anticipatory breach by you.

You irrevocably waive all rights to seek injunctive or other equitable relief, or to enjoin or restrain the operation of the Service or any Domates game, exploitation of any advertising or other materials issued in connection therewith, or exploitation of the Service or any content or other material used or displayed through the Service and agree to limit your claims to claims for monetary damages, limited by Section 7 (if any).

10.7. Force Majeure

Domates shall not be liable for any delay or failure to perform resulting from causes outside the reasonable control of Domates, including without limitation any failure to perform hereunder due to unforeseen circumstances or cause beyond Domates's control such as acts of God, war, terrorism, riots, embargoes, acts of civil or military authorities, fire, floods, accidents, strikes, or shortages of transportation facilities, fuel, energy, labor or materials.
