Overview

The five Massachusetts natural gas companies¹ are creating a Non-Gas Pipeline Alternative (NPA) framework to inform future decisions about the gas system. The NPA framework will enable natural gas companies to evaluate both traditional pipeline investments and alternative options like electrification, thermal networks, energy efficiency, and demand response.

The natural gas companies want to gather input from a wide range of people with different viewpoints to ensure the NPA framework meets customer needs while maintaining safety and reliability as the gas system changes. The companies conducted a formal request for proposals and have hired a team of independent consultants (E3, Apex Analytics, and Efficiency for Everyone) to lead the stakeholder input process. This announcement presents the various stakeholders selected to contribute to the process via the NPA Working Group.

Selection process

Interested members applied via an online form, expressing why they were interested in participating, the perspective they bring, their commitment to the Working Group, and listing of participation in any public processes/meetings on the energy transition. Applications were processed through a multi-step selection process facilitated by Apex to ensure a balanced representation across the various stakeholder types listed below:
